Vacancy Circular

It is proposed to fill up one post of Agriculture Commissioner (General Central Service, Group-'A' Gazetted, Non-ministerial) in the Department of Agriculture and Farmer's Welfare in Level-15 of the Pay Matrix (Rs. 182200-224100) on deputation (including short term contract) basis.

2. Eligibility Conditions: Deputation (including short term contract):

Officers of the Central Government or State Governments or Union Territories or Agricultural Universities or Indian Council of Agricultural Research or Recognized Research Institutions:-

(A) (i) holding analogous posts on regular basis in the parent cadre or department; or

(ii) having 3 years regular service in the grade rendered after appointment thereto on a regular basis in Level-14 (Rs. 144200-218200) in the pay matrix or equivalent in the parent cadre or department; and

(B) possessing the following educational qualifications and experience:-

(i) Degree in Agriculture followed by Post Graduate Degree in any branch of Agriculture Sciences from a recognized University or equivalent;

(ii) Eighteen years experience in the field of Agricultural Development or Extension or Research.

3. List of duties / responsibilities attached to the post of Agriculture Commissioner is as under:-

- 1) To advise the Ministry in the formulation of Agricultural Policies in the Country.
- 2) To help develop the programme of agricultural production particularly in respect of Commercial Plantation and Fruit Crops and Vegetable and also to accord technical approval of the Centrally Sponsored Schemes relating to these crops.
- 3) To keep under constant review the agriculture development programme in different states and specific supervision over implementation of Centrally Sponsored Schemes.
- 4) To supervise the work of the Crops Divisions in the Ministry and of the Regional Offices of the Commercial Crops for Jute, Cotton, Sugarcane, Oil Seeds, Tobacco, Coconut, Lac, Cashew, Arecanut and Spices located in different parts of the Country.
- 5) To represent the Ministry in the national and international seminars and conferences particularly organized under the auspices of the FAO of the UN.
- 6) To advise the various national official & non-official organization engaged in promoting the agricultural development programme in the country.

4. Regulation of pay and other terms of deputation: -

The pay of the selected candidate will be regulated under the provisions contained in the DoPT O.M. No. 6/8/2009-Estt.(Pay-II) dated 17/06/2010 as amended time to time.

5. Age-limit:-

The maximum age-limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

6. Period of deputation: -

Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the central government shall ordinarily not exceed five years.
