EMPANELMENT OF SPECIALIST ON CASE TO CASE BASIS IN ESIC HOSPITAL, MANESAR FOR

A PERIOD OF ONE YEAR THROUGH WALK-IN-INTERVIEW TO BE HELD ON 07.12.2021.

ESI Corporation is a statutory body constituted under the ESI Act, 1948 under Ministry of Labour & Employment, Government of India. ESIC Hospital, Manesar is a 100 bedded hospital and committed to provide cashless secondary care/super specialty services to the ESI beneficiaries. To meet the shortage and to provide in house services to the ESI beneficiaries, ESIC proposes to empanel Specialists/Super Specialists for "on demand professional services" for a period of one year.

The details of empanelment of Specialists/Super Specialists (department- wise) is as under:

1. Date of Interview: 07.12.2021
2. Candidates are advised to report to the office of Medical Superintendent, ESIC Hospital, Manesar latest by 11.00 am on the date of Interview. They must carry all relevant documents in support of educational & professional qualifications.

1. Empanelment of Specialists/Super Specialists

- 1.1 The doctors will be empaneled on the basis of the eligibility criteria, capitation fees as mentioned above.
- 1.2 A list of empaneled doctors as L1, L2 and L3 (as per requirement) shall be prepared based on % of CGHS package/procedure rate in the increasing order.

2. Terms and conditions

- 2.1 The Appointing Authority reserves the right to cancel the offer/ advertisement without assigning any reason thereof.
- 2.2 The empaneled doctor shall sign the acceptance of offer letter.
- 2.3 Age limit Candidate should not be more than 70 years on the date of interviews.

3. Duties & Responsibilities of empaneled doctors

- 3.1 The empaneled doctor, whenever called for, will provide the professional services to the ESIC beneficiaries at ESIC Hospital as per terms and conditions based on offer of professional fees linked to CGHS package/ procedure.
- 3.2 The empaneled doctor shall also provide post procedure care with minimum of two visits per day (one in morning and another in evening), till the patient is discharged.
- 3.3 The empaneled doctor will be available round the clock for professional services.
- 3.4 The doctor is required to complete the paper work. Case sheet as required by the ESIC Hospitals.
- 3.5 The doctors may also advise / recommend, referring to refer the entitled beneficiaries to tie-up/higher center if the condition of the patient so requires.
- 3.6 The doctor must ensure that the record of all his indoor patients are updated, medicines and services are delivered to the patient.
- 3.7 The doctor will be responsible for any deficiency/negligence in the delivery of professional services.

4. Responsibilities of ESIC

- 4.1 L1 empaneled doctor from the list shall be called for the professional services. However, if the first (L1) doctor on empanelment is not available then the next empaneled doctor on the panel may be called up based on the urgency of procedure.
- 4.2 If the empaneled doctor does not provide the post-operative care after the procedure, Medical Superintendent may call next empaneled doctor for the same and proportionate deduction shall be made from the first empaneled doctor who had performed the procedure.
- 4.3 To provide the infrastructure to the empaneled doctor to perform professional services.
- 4.4 To provide required manpower to assist empaneled doctor during the delivery of professional services.
- 4.5 To provide drugs, dressings, consumables etc., for professional procedure.
- 4.6 To shift the patient to higher center in case of emergency or exigency and when the situation arises in order to save the life of the patient.

5. Agreement & Applicability of laws

- 5.1 The both parties shall have the full power and authority to enter into this agreement and to perform the acts required of it.
- 5.2 The Parties shall comply with all applicable Laws, Statutes, Ordinances, Orders, Rules and Regulations in operation in the country.

6. Termination of empanelment

- 6.1 It is expected that the doctors will observe the highest standard of ethics during the execution of the empanelment.
- 6.2 **The following instances may result in termination of empanelment:**
 - Any collusion with the doctors/staff.
 - Malpractice
 - Misrepresentation
 - After joining of the regular specialist/super specialist

- Medical negligence in providing/delivering his medical services
- Any other as decided by Medical Superintendent

The appointing authority may terminate the agreement of the empaneled Specialists/Super Specialists with or without assigning any reason whatsoever after giving a notice of 30 (thirty) days to the doctor.

7. Period of empanelment

7.1 Such empanelment is valid for one year from the date of signing of contract.

7.2 It is extendable for one year with mutual consent of both the parties.

8.2 Certificates of educational qualification, professional qualification, registration of Medical Council and experience.
