In order to select meritorious TET and B.Ed. qualified candidates in a transparent and impartial manner, online applications are invited from the eligible candidates who are citizens of India as defined in Article 5 to 8 of the "Constitution of India" and permanent resident of Assam for filling up of the posts of Post Graduate Teachers of the different Govt. Secondary Schools under the Secondary Education Department, Govt. of Assam in the scale of pay of Rs. 22,000/- to 97,000/- including Grade Pay of Rs. 11,800/- PM (under pay band III) plus other allowances as admissible under rules.

The process of online application will remain open from 15th January, 2022 and will be accepted till 12.00 Midnight of 31st January, 2022 in the official website at www.madyhamikassam.gov.in

The candidate, who submits online application, shall select district, medium of school and category of post through the official website. Kindly visit official website www.madyhamikassam.gov.in and visit recruitment tab and apply online. Candidates can appear in the interview in multiple Districts provided they are in a position to appear in such interview in view of the fact that the verification process at the District level, simultaneously in all the Districts at the same date and time.

1. Academic and professional Qualifications:

- i. The applicant must be Post Graduation in concerned subject with at least 50% marks (or its equivalent) from recognized University and Bachelor of Education (B.Ed.) from National Council for Teacher Education (NCTE) recognized institution but degrees obtained from off-campus and distance education institution shall not be considered as valid.
ii. The applicant shall have to appear and passed in Higher Secondary Teachers Eligibility Test (TET) in the concerned cadre, conducted by the Government scoring a minimum of 60% marks in case of reserved categories candidates and minimum 55% marks in case of Scheduled Castes/ Scheduled Tribes/Other Backward Classes and Persons with disabilities candidates:
Provided that for the teachers working regularly at a sanctioned Graduate post in any Government High School or Higher Secondary School for a minimum period of 15 years having requisite academic and professional qualification for the post of Post Graduate Teacher appearing to qualify in TET shall be optional and they shall be awarded with a weightage of 60 marks for their 15 years of continuous teaching experience and those who have appeared and qualified in the TET shall get the TET qualified marks in lieu of the weightage given for the experience.
Provided further that any experienced teacher who has appeared but could not secure the minimum qualifying 60 marks in the TET shall be awarded at least 60 marks in respect of their experience if he or she has already completed 15 years of teaching experience, any marks secured by such experienced teacher over and above 60 qualifying marks in TET shall be counted additionally in respect of TET for such teacher for the purpose of selection for the post of Post Graduate Teacher.
iii. In addition to the academic and professional qualification, the applicant must satisfy the following criteria:
(a) In case of Assamese Medium School, the applicant must have passed HSLC or equivalent examination with Assamese language as one of the subjects or having diploma in Assamese Language issued by the Assam Sahitya Sabha or read up to HSLC level in Assamese medium School.
(b) In case of Bengali Medium School, the applicant must have passed HSLC or equivalent examination with Bengali language as one of the subjects or having diploma in Bengali issued by the Barak Upajyoti Bangya Sahitya O Sanskrit Sammelan or read up to HSLC level in Bengali medium School.
(c) In case of Hindi Medium School, the applicant must have passed HSLC or equivalent examination with Hindi language as one of the subjects or read up to HSLC level in Hindi Medium School.
(d) In case of Bodo Medium School, the applicant must have passed HSLC or equivalent examination with Bodo language as one of the subjects or read up to HSLC level in Bodo medium school.
(e) In case of English Medium School, the applicant must have passed HSLC or equivalent examination with alternative English as one of the subject or read from Class XI onwards in English medium school.

2. Physical fitness:

- The applicant for the post of Graduate teacher shall be:-
i. of sound health both mentally and physically and free from any organic defect or bodily infirmity which is likely to interfere in the efficient performance of his duties;
ii. required to undergo medical examination before appointment to the service.
3. Criteria for selection of Post Graduate Teacher:
(i) 100 marks on percentage of marks in MA/ M.Com/ M.Sc. Examination
(ii) 100 marks on percentage of marks in BA/ B.Com/ B.Sc. Examination (in case of Major/ Hons. The marks obtained in Major/ Hons shall be taken into consideration.)
(iii) 10 marks on percentage of B. T. (B. Ed.) Examination.
(iv) 100 marks on percentage of marks in TET Examination or 60 marks for 15 years of experience as a Graduate Teacher in Govt. High/Higher Secondary School having requisite academic and professional qualification. Any experience teacher who has appeared but could not secure the minimum qualifying 60 marks in the TET, shall be awarded at least 60 marks in respect of their experience if he or she has already completed 15 years of teaching experience. Any marks secured by such experienced teacher over and above 60 qualifying marks in TET shall be counted additionally in respect of TET for such teacher;
(v) 10 marks for NCC certificate (10 marks for 'C' certificate and 5 marks for 'B' certificate);
(vi) 10 marks for participation in recognized sports at Hotion and national level representing Assam;
(vii) 10 marks for achievements in fine Arts and Cultural activities representing the State officially at National level.

4. Other conditions :

- a. In pursuance of the Govt. OM No. ASE.238/2014/213, dtd. 22.11.2019, those Institutions having territorial jurisdiction outside the State of Assam but having a study centre in the State and such study centres if recognized by DEC under UGC, the degrees/ certificates issued by such off campus institutions shall not be considered as valid for the purpose of employment under Education Department. However, degrees/ diplomas conferred by the KKHSSOU, IGNOU, IJDL under Gauhati University and distance education under Dibrugarh University shall be considered as valid for the purpose of employment.
b. Any Post Graduate Teacher serving in Provisionalised / Government Secondary Schools, who has not completed 3 (three) years of service, are not allowed to apply in response to this advertisement. In case, it is detected, at any stage, appropriate departmental action will be taken against the teacher concerned treating the same as violation of Govt. Office Memorandum No. ASE.626/2021/13, dt. 15.12.2021
c. The applicants applies for the post of UR category and OBC /MOC/ ST /P/ (ST/H) / PWD category must have minimum 60% marks in both papers in Higher Secondary TET.
d. A candidate must not be less than 21 years of age and not more than 38 years for open category, 40 years for Ex-Service, 41 years for OBC/ MOC/ and 43 years for SC/ ST/P/ST(H) and 48 years for Persons with Disability (PWD) as on 1st January, 2022. The eligible candidates shall apply online in the official website from 12.00 Noon of 15th January, 2022 and will be accepted till 12.00 Midnight of 31st January, 2022. No offline application will be accepted in this regard.
e. The Teachers working regularly against a sanctioned Graduate post in any Govt. High School / Higher Secondary School for a minimum period of 15 years having requisite academic and professional qualification, who has appeared but could not secure minimum qualifying marks, may also apply for the post of Post Graduate Teacher.
f. During the selection, the Rules adhered in the Assam Secondary Education (Govt. Schools) Service Rules, 2020 will be strictly followed.
g. If an applicant desires to apply in more than one district, separate online application will be required. Candidates can appear in the interview/ verification process in multiple Districts provided they are in a position to appear in such interview/ verification process will be conducted by the Selection Committee, simultaneously in all the Districts at the same date and time.
h. The online applications and documents submitted by the candidates will be verified along with their original testimonials at the District Headquarters of the concerned District. The district-wise detailed

schedule and venue for screening / verification of documents will be notified in the official website. No TA / DA are admissible for verification process. District-wise verification will be conducted simultaneously online and in the districts. Candidates will be informed collectively by the Director of Secondary Education, Assam in the official website.

- 1. There will be reservation / relaxation for Economically Weaker Sections (EWS) as per Govt. Notification No. ABP/07/2014, dated 10.04.2019.
j. The online application and documents submitted by the candidate will be verified using modern technology on the same date and time in the districts. Candidates will be informed collectively by the Director of Secondary Education, Assam in the official website.
k. The candidate will be cancelled forthwith, if any kind of fraudulence / discrepancy regarding any information / documents uploaded by the candidate is established by the appropriate authority at any point of time. The candidate will be debarred from any future recruitment under Government of Assam and subsequent legal action will be also initiated against such candidate.
l. In conformity with the "Right of Persons with Disabilities Act, 2016" and in compliance of the SOP No. SWD/290/2017, dtd. 28.07.2017 issued by the Govt. of Assam, Social Welfare Department, it is specified that the reservation for persons with disabilities will be as follows:-
i. 1% for blindness and low vision
ii. 1% for hearing impaired and
iii. 1% for locomotors disability or cerebral palsy.
p. A candidate will mention and select the name of the district for which the application is submitted.
q. When the candidates appear for the verification / screening process, they must produce certificates, testimonials and all other documents, in original, that was uploaded during the application stage.
r. Reservation shall be applicable as per existing State Government Rules.
s. Separate Merit Lists will be prepared for each category of posts.
t. Applicants are required to visit www.madyhamikassam.gov.in regularly for any update.
u. Correspondence and addendum will be published as and when required in the official website at www.madyhamikassam.gov.in.

l) No additional documents will be accepted if it is submitted after closing of the online application process.
m) Any documents issued after closing of the online application process will not be accepted.

Please Note:

- a. After successful submission of the online form, candidates shall take a print out of the form and submit the same along with self-attested copies of mark-sheets and certificates in support of the educational qualification, caste/ disability TET, B.E.D and curricular activities at the time of document verification before the Selection Committee. Candidates must also produce original documents that have been uploaded with the online application to the Selection Committee.
b. After submitting the online application form, the candidates will get a Unique Number against the submitted application and will keep the printout of the unique Number for all future references.
c. Candidates may note that failing to qualify in Screening/ Verification of documents will result cancellation of their candidature. Online communication in this regard will be entertained.
d. The office will not be responsible for any lapse in submission of online application due to any technical problem.

ix. Certificate of recognized Sports at national level representing Assam
x. Certificate of Achievements in fine arts and cultural activities representing the state officially at national level.
xi. Certificate of Ex-servicemen issued by the Director, Sainik Welfare Board.
