6. Further it is submitted that, instructions were given to the Principals/ Superintendents of Govt. Medical Colleges and teaching hospitals to fill up the above said posts through District Selection Committee and maintain Rule of Reservation in the recruitment process and to follow the conditions mentioned in the G.Os reference cited.
Method of recruitment:

7. Reservation:-

a) Local and Non local reservations will be followed as per guidelines Rule of Reservation will be followed as per rules in vogue. Evaluation of various physical disabilities and procedure for certifications will be as per order contained in G.O. Ms.No. 56 WD,CW&DW(FW) Dept. 02-12-2003 & G.O.Ms.No. 31 /WD,CW &DW(DW) dept. dt. 01-12-2009.

b)Reservation to Local Candidates: Reservation to the local candidate is applicable as provided in Article 371-D as per G.O. Ms.No. 674,AG)SPF-A) Dept. dt. 20-10-1975 and rules amended from time to time and as in force on the date of notification. The candidates claiming local status should obtain the required study certificates (from 4th class to 10th class or S.S.C.) or Residence certificate in proforma prescribed for those candidates who have not studied in any educational Institution as the case may be. The relevant certificate with authorized signature shall be produced as and when required.

8. Age:-

a)Minimum 18 years and maximum 42 years as on 1-7-2021 as per G.O.

Ms.No. 05G.A. (Ser.A) Dept. dt. 27-09-2021(no person shall be eligible if less than 18and is more than 42 years)

b) For SC/ST/BC & EWS upper age limit is relaxed by five years

c) For Physically handicapped persons upper age limit is relaxed by 10 yrs

D) For Ex service men shall be allowed to deduct from his age a period of 3 years in addition to the length of the service rendered by him in the armed forces.

9. The applicant must enclose a DD towards application processing fee in favour of the Principal, S.V. M.C. Tirupati, (if candidate is eligible for more than one post he/she is required to enclose DD for each post and apply for each post separately) as given below.

a) For OC. Candidates -- Rs. 500/-

b) For SC/ST/BC candidates --Rs. 300/-

c) For Physically challenged candidates- No fee Exempted from fee.

10. Important note on Recruitment process and procedure of selection.

The recruitment will be processed as per the notification and as per the rules

and instructions issued by the Government and also as decided by the District selection Committee, Chittoor from time to times in terms of respective special Rules/Adhoc rules governing the recruitment and the related G.Os, rules etc are applicable.

The various conditions and criteria prescribed herein are governed by the A.P. State and Subordinate Rules 1996 read with the relevant special rules applicable to any particular services in the departments. Any guidelines or clarifications are based on the said rules, and in case of any necessity any matter will be processed as per the relevant General and Special Rules as in force.

11. The selection to this recruitment will be based on the merit as given below.

Note2: The above Covid-19 shall be applicable only to the persons who have rendered their services for Covid-19 on Contract /Outsourcing/Honorarium b basis and are appointed by the District Collectors or any other competent authority exclusively for Covid-19 purpose , based on orders issued by the Government from time to time.		

12. Tenure of appointment and important conditions:

The selected candidates in this recruitment notification should work for a period one year from the date of joining at place of posting, otherwise their candidature will not be considered for further any kind of benefits from the Government. The tenure of selected candidates in this recruitment notification will be one year from the date of joining and the District Selection Committee, Chittoor reserves all the rights to terminate the contract/outsourcing services of any candidate /candidates at any time without giving any prior notice as per directions of the Government from time to time.

13 Debarment:

Candidates should make sure of their eligibility to the post applied for and that, the declaration made by them in the format of application regarding their eligibility is correct in all aspects. Any candidate furnishing incorrect information or making false declaration his /her eligibility at any stage or suppressing any information, is liable to be debarred up to 5 years from applying for any of the notifications conducted by the APPSC/D.S.C. /Any other recruiting agency and their candidature for this recruitment will be rejected summarily.

The District selection committee, Chittoor is vested with conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by anyone causing or likely to cause breach of this duty in such a manner or by such action to violate or likely to violate the fair practices followed and ensured by DSC, Chittoor will be sufficient cause for rendering such questionable means as ground for debarment and other consequences as per law and rules.

14. District Selection Committee decision to be final:

The decision of the District selection committee in all aspects and respects pertaining to the application and its acceptance or rejection as the case may be, conduct of recruitment at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects binding on all concerned under the powers vested with it as per rules in force.

District Selection committee also reserves its rights to alter and modify the terms and conditions laid down in the notification at any time as warranted by any unforeseen circumstances arising during the course of this process, or as deemed necessary by the D.S.C.
