The candidates selected for the written-test-cum interview should bring an application with full bio-data addressed to the Director, ICAR Central Tuber Crops Research Institute, Thiruvananthapuram with duly-attested photocopies of certificates and mark sheets (from SSLC onwards), experience certificates, publications/ additional qualifications related to the job.
