- 3. Candidates are requested to go through carefully the details of post and instructions.

- 4. Candidates working in Government / Semi Government / Public Undertakings / Autonomous bodies should apply through proper channel and they should enclose a "No Objection Certificate" from the present employer.
- 5. Only screened in applicants will be called for written test. Only shortlisted candidates as explained above will be called for Practical Test and Interview.
- 6. Candidates are required to have a valid Email ID and Mobile Number & convey the same in the application. It should be kept active during the currency of this recruitment. IMSc will send intimation / call letters for written examination only through the registered email ID.

- 8. At the time of written examination, candidates must bring a printout of the call letter sent to them through email printed properly with header.
- 9. Before applying for the post, candidates should ensure that they fulfill all the eligibility norms. Candidates should have the requisite Educational & other Qualifications from recognised University / Institute as on the date of submission of the application.
- 10. Period of experience as prescribed in the Advertisement will be determined with reference to the last date for submission of application.
