NOTIFICATION

The Kerala State Road Transport Corporation (KSRTC), invites applications from qualified and competent candidates for appointment to the posts of **General Manager (Technical) and General Manager (Finance)** on **contract basis**. Interested candidates may apply via **ONLINE** mode only by filling the prescribed application form given in the website of Centre for Management Development (CMD), Thiruvananthapuram (www.cmdkerala.net). The details are given below. The online application submission link will open on **07/01/2022 (09:00 A.M.)**. The last date for submitting online application is **21/01/2022 (05:00 P.M.)**.

Note: Candidates will have to upload their updated Curriculum Vitae (CV), passport size photograph (taken within six months), signature and copies of certificates proving qualification and experience while submitting the application. The photograph and signature must be in JPEG format. The size of the photograph must be less than 200kB and the size of the signature should be less than 50 kB. The CV and the copies of certificates shall be either in JPEG format or in PDF format and each attachment shall not exceed 3MB in size.

Conditions of experience and age limit may be relaxed in the case of exceptionally qualified candidates.

Note:

- The period of Contract appointment shall be initially for a period of three years which may be extended up to five years depending on the performance of the candidate.
