Details of terms & conditions for Contractual Appointment for the above mentioned posts as under

Terms & Conditions For Contract Appointment

1. The appointment is purely on CONTRACT BASIS for a period of 03 months with effect from the date of joining which may be further extended as per functional requirement of the Institute; or till such time the regular arrangements are being made, whichever is earlier. If the contract is not extended further, the same will lapse automatically. The appointment may be terminated at any time, giving one month's notice or by paying one month's salary by the appointee or failure to complete the period of three months to the satisfaction of competent authority. However, the Competent Authority reserves the right to terminate forthwith without assigning any reason thereof.
2. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
3. The appointee shall not be entitled to any other benefits like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
4. The appointee shall not have any claim or rights for regular appointment to any post at LGBRIMH.
5. The appointee shall be on the whole time appointment of the LGBRIMH and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
6. On appointment, the appointee will be required to take an Oath of Allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma. Also, they will have to sign on Deed of Agreement.
7. Other conditions of service will be governed by relevant rules and orders issued from time to time.
8. For Registration eligible candidates are requested to e-mail necessary documents (all relevant original testimonials/BIO-DATA, attested copies of certificate/ one PP size photograph) to institute e.mail id lgbrimh@yahoo.co.in on **10.01.2022**.
9. If any declaration given or information furnished by him/her proves to be false or if he /she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
