Applications are invited for the appointment of Guest Faculty in the Department of Indian Theatre, Panjab University, Chandigarh as per UGC/ PU norms.

Interested candidates are required to submit the copy of the application in the prescribed proforma: (UGC regulation 2018 form <https://forms.puchd.ac.in/forms/20200122155429-directrecruitmentassistantprofessorapplicationformasperugcregulation2018.pdf>, along with the self-attested copies of relevant certificates and documents to the Office of the Chairperson, Department of Indian Theatre, PU on the day of the Walk in Interview. All the applicants are advised to bring their original certificates and other relevant documents for verification along with the duly filled application form and attested copies of all the certificates/documents and passport size photographs.

Essential Minimum Qualifications:

1. Good academic record as defined by the concerned university/department with at least 55%marks (50% marks for SC/ST/Physically & Visually Handicapped) or an equivalent grade in a point scale wherever grading system is followed at the Master's Degree level in the relevant subject (Theatre) from a recognized Indian University, or an equivalent degree from an accredited foreign university.
2. Besides fulfilling the Above Qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
3. Notwithstanding Anything Contained in Sub-clauses (i) and (ii) candidates, who are, or have been awarded Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET/ as per Panjab University rules.
4. Desirable Ph.D. in the subject of Theatre.
5. The appointment shall be made as per University Grants Commission Regulation, 2018. (UNIVERSITY GRANTS COMMISSION NOTIFICATION, New Delhi -18th July, 2018).

The above assignment is on lecture basis with a token honorarium of Rs. 1000/- per lecture with an upper limit of Rs. 25,000/- per month. The candidate shall have to undertake that He/she will not draw any fellowship/stipend or any financial assistance from any agency.

Note:

1. No TA/DA will be paid to the candidates for attending the interview.
2. The tenure of the above said posts can be varied.
3. Eligibility for the said posts will be determined following the submission of all the requisite documents by the stipulated date and after checking the original documents.
