Qualification	Bachelor's Degree in Commerce (B. Com) with Intermediate Level Pass Certificate from Institute of Chartered Accountants of India (ICAI) or Institute of Cost Accountants of India (ICAI)
Age Limit	Below 25 years as on the last date of submission of Online application
Stipend	Rs. 15,000/- (Rupees fifteen thousand only) per month during the 1 st year which will be enhanced to Rs. 20,000/- per month in the 2 nd year, in case engagement is extended for second year.
Period of training	12 months / 24 months
Scope of Work	The selected trainee(s) will be required to work for 8 hours per day for 5 days in a week. They will be engaged in the works related to Finance & Accounts of the Institute under the supervision of the Officers of the Finance & Accounts Section.
Others facilities	Selected Trainee(s) may be given shared unfurnished accommodation subject to availability. License fee, water charges, electricity charges and charges for any other services rendered shall be recovered as per Institute rules.
Leave	Selected trainee will be entitled to 2.5 days of Leave for each completed month of work.
