

It is proposed to fill up the vacancy of Chairperson and Six Members for the Tamil Nadu Commission for Protection of Child Rights". Accordingly applications are invited by the Tamil Nadu Commission for Protection of Child Rights.

Eligibility Criteria

1. The applicant for the post of Chairperson and Members shall be from the following fields from amongst persons of eminence ability integrity outstanding and experience in
 - i) Education
 - ii) Child health , Care, Welfare or Child Development.
 - iii) Juvenile Justice or care or neglected or marginalized children or Child with disabilities.
 - iv) Elimination of child labour or Children in distress.
 - v) Child Psychology on Sociology and
 - vi) Laws relating to Children.

2. The Norms for Selection of Chairperson and Members a person shall not be selected as Member unless he
 - (a) Is an Indian national.
 - (b) Possesses a post graduate degree from a recognized University.
 - (c) Has not been convicted or sentenced to imprisonment for an offence under any law for the time being in force.
 - (d) Has not been removed or dismissed from service of the Central or State Government or a body or corporation owned or controlled by Central or State Government.

3. No person having any past record of violation of human rights especially child rights or criminal conviction shall be eligible for appointment as Chairperson and Members of the Commission.
4. The person selected for the post of Chairperson and Members shall not hold any other post in any Governmental, Quasi-Governmental, Public Sector or Non-Governmental organization or hold any other position whether for profit or not.
5. The applicant for Chairperson should have not exceeded 65 years of age and the Members should not have exceeded 60 years of age of as on 01-04-2022.



Eligibility Criteria for the post of Chairperson and 6 Members of Tamil Nadu Commission for Protection of Child Rights.

1. The applicant for the post of Chairperson and 6 Members shall be an eminence person and has done outstanding work for promoting the welfare of children.
2. The applicant for the post of Members should have experience in the fields of
 - v i) Education
 - v ii) Child health, Care, Welfare or Child Development.
 - v iii) Juvenile Justice or care or neglected or marginalized children or Child with disabilities.
 - v iv) Elimination of child labour or Children in distress.
 - v v) Child Psychology or Sociology; and
 - v i) Laws relating to Children.
3. The Norms for Selection of Chairperson or Members a person shall not be selected as Member unless he
 - (a) Is an Indian national.
 - (b) Possesses a post graduate degree from a recognized University.
 - (c) Has not been convicted or sentenced to imprisonment for an offence under any law for the time being in force.
 - (d) Has not been removed or dismissed from service of the Central or State Government or a body or corporation owned or controlled by Central or State Government.
4. No person having any past record of violation of human rights especially child rights or criminal conviction shall be eligible for appointment as Members of the Commission.
5. The person selected for the post of Members shall not hold any other post in any Governmental, Quasi-Governmental, Public Sector or Non-Governmental organization or hold any other position whether for profit or not.
6. The applicant for Chairperson should have not exceeded 65 years of age and the Members should not exceed 60 years of age as on 01-04-2022.
