1. The candidates of only Indian Nationality can apply for these posts.
2. There is No Application Fee for applying to any post.
3. The Candidates must carry the original photo id proof which has been mentioned in the application, at the time interview and document verification.
4. The Board reserves the right to post the selected candidates anywhere in Jharkhand.
5. Applicants are required to submit the self attested copies of certificates and supporting documents with the application form. However, the original of the same shall be produced at the time of documents verification.
6. After submitting the application, applicants are advised to visit the JSPCB website frequently for any update on the status of this Notice for Hiring.
7. Applicants are advised to ensure before applying, that they possess essential qualification and experience for the post. The Experience, Qualification and age will be reckoned as on the last date for submission of application i.e. 2nd May, 2022 till 5 P.M. No updating of qualification and experience will be entertained after the last date.
8. Application once submitted cannot be altered / resubmitted, under any circumstances. Further, no request with respect to making changes in any data / particulars entered by the candidate in the Application will be entertained, once the application is submitted. Therefore, please keep all data / details ready before you start filling up the Application.
9. The persons applying for more than one post must apply separately.
10. JSPCB shall verify the antecedents and documents submitted by applicants at any time, at the time of appointment or during the tenure of service. In case, it is found that the Applicants have submitted fake documents or the applicants have undesirable clandestine antecedents / background and have suppressed the material information, his / her services shall be liable to be terminated.
11. The character of a person for direct recruitment to the service must be such as to render him / her suitable in all respect for appointment to the service. Persons dismissed by the Union Government or by a State Government or by a Local Authority or a Government

- Corporation owned or controlled by the Central Government or State Government will be deemed to be ineligible for appointment.
12. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issuance of appointment letter, JSPCB reserves the right to modify / withdraw / cancel any communication made to the Applicants.
 13. The reservations / relaxations policy for SC / ST / OBC / PwBD / EWS applicants will be as per the existing Govt. of Jharkhand policy. Applicants should clearly state to which category they belong.
 14. The applicants serving in Govt. / Semi. Govt. / PSUs / Autonomous Organization must obtain No Objection Certificate from their employer and produce it at the time of interview / documents verification. In case the applicant fails to submit the No Objection Certificate from his employer, his candidature will not be considered for appointment.
 15. Canvassing in any form on behalf of or by any applicant will disqualify him / her from being considered for post.
 16. Appointments under this Recruitment are contractual in nature with a probation period of 3 months and the same shall be confirmed depending upon satisfactory performance of the incumbent.
 17. The Board reserves the right to:
 - a. Withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect.
 - b. Fill or not to fill up some or all the posts advertised for any reasons whatsoever
 - c. Increase/decrease the number of posts without giving any reason.
 - d. Any edition/deletion and changes in matter of terms and conditions given in this notification of recruitment.
 18. Request for change of mailing address or e-mail address or Mobile No. during the process of recruitment will not be entertained under any circumstances. JSPCB will not be responsible for any loss of e-mail, loss of any communication due to wrong address provided by the candidates.
 19. Applicants shall have to produce original testimonials and No Objection Certificate (as per clause 14) at the time of document verification.
 20. Any corrigendum/addendum pertaining to this advertisement, the same shall be published on JSPCB website only. Accordingly, all applicants in their own interests are advised to regularly visit JSPCB website i.e. www.jspcb.nic.in. They should also regularly check their e-mail account for updates.
 21. No TA / DA and accommodation shall be provided for attending Interview.
 22. Candidates, who have obtained Degrees or Diplomas or Certificates for various courses from any Institution, declared fake / de-recognized by the UGC / AICTE / PCI shall not be eligible for being considered for recruitment to the posts advertised. If this is detected at any stage during their service, their service will be terminated forthwith.
 23. No interim correspondence whatsoever will be entertained from Applicants regarding conduct and result of test(s) and reasons for not being called for test(s)
 24. In case of any dispute / ambiguity that may occur in the process of selection, the decision of the Competent Authority of JSPCB in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of examination / interview will be final and no query or correspondence will be entertained in this connection from any applicant.
 25. No person shall be recruited unless he / she is in good mental and physical health and free from any physical defect that is likely to interfere with the efficient performance of his / her official duties. Candidates who are finally approved for the appointment, he / she shall produce Medical Certificate from an authorized Government Medical Officer at the time of joining the JSPCB.

26. A Candidate's admission to the Interview and subsequent process is strictly provisional. The mere fact that the call letter has been issued to the candidate does not imply that his / her candidature has been finally cleared by JSPCB. JSPCB would be free to reject any application, at any stage of the process, cancel the candidature of the candidate in case it is detected at any stage that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information / Certificate / documents or has suppressed any material fact(s). If any of these shortcoming(s) is / are detected after appointment in JSPCB, their services are liable to be summarily terminated as per Rules.
27. Errors and omissions in notification and selection process are subject to corrections as per Rules.
28. The personnels shall be appointed on a short-term contract basis initially for a period of 12 months. Based on his / her performance and requirement of his / her services, the contract can be further extended up to a maximum of two terms (12 months each) or 65 years of age whichever is earlier in case of retired officers and on yearly basis as decided by the Board for other personnels (except retired).
29. Retired candidates should not be more than 62 years and other candidates should not be more than 56 years of age as on last date of submission of application in JSPCB.
30. The consolidated fee/remuneration payable to retired persons on short- term contract basis shall be payable as per Sankalp Sankhya no 6/S-5(Bhatta)-03/20111243/Vi ranchi dated 28/04/2016 of the Planning Cum Finance Department (Finance Division), Govt. of Jharkhand and for other persons it will be fixed Emolument (Basic pay + DA + TA + HRA + MA etc.) with no increment on yearly basis.
31. The Income Tax or any other tax liable to be deducted as per the prevailing rules will be deducted at source before effecting the payment for which JSPCB will issue TDS certificates.
32. The engagement of the personnels on short-term contract basis can be terminated at any time without assigning any reason. However, if a personnel is not willing to continue for what so ever reasons may be, he / She may give minimum one month notice to the office.
33. The engagement of personnels would be on full time basis and the personnels can be required to work on holidays also, if need be, for which no additional fees will be paid.
34. The appointment will be purely on contractual basis.
35. The personnels shall be eligible for Casual Leave as per the policy of JSPCB. Any un-availed leave in a calendar year cannot be carried forward to the next calendar year.
36. The personnels appointed by the Board, shall in no case represent or give opinion or advice to others in any matter which is not in the interest of the Board.
37. Application received in response to this advertisement will be shortlisted on the basis of educational qualification and work experience in relevant field. Only shortlisted candidates will be intimated and the Board reserves the right to reject any or all applications without assigning any reason.
38. The selection/merit list of the candidates will be prepared on the basis of weightage of educational qualification/experience and interview.
39. The reservation will be applicable as per the Government of Jharkhand norms.
40. The personnels shall be appointed on a short-term contract basis initially for a period of 12 months or till the regular appointments are being done, whichever is earlier.
