PARA-1:

Applications are invited through off-line mode (Physical applications) from eligible candidates for various posts to work purely on contract & Out-sourcing basis in APVVP Hospitals of Prakasam District, details are at para 1.8.

The candidate is required to download the application forms from website (https://prakasam.ap.gov.in/) and the copy of application form along with necessary documents shall submit in-person/by Registered post from 23-05-2022 to 26-05-2022 (26.05.2022 is the last date for submission of applications in-person/registered post). This office is not responsible for postal delay if any and applications received after 05.00 PM of 26.05.2022 will not accepted in any circumstances.

The filled-in applications along with necessary documents shall submit at office of the District Coordinator of Hospital Services (APVVP) Old RIMS Campus, Opp. Collectorate, Ongole.

The selection to the posts will be on the basis of final general merit cum rule of reservation.

The applicant is required to visit the Prakasam District official website regularly to keep himself/herself updated until completion of the recruitment process. The website information is final for all correspondence. No individual correspondence by any means will be entertained under any circumstances.

All desirous and eligible candidates shall apply after satisfying themselves as per the terms and conditions of this recruitment notification. Submission of application forms by the candidate is considered that he/she has read the notification and shall abide by the terms and conditions laid down there under.

If candidate is eligible for more than one post he/she is required to apply for each post separately.

PARA: 2:: Educational (Academic & Technical) qualifications to various posts:

The candidate should possess the prescribed academic qualifications as per the date of this notification. The date of this notification shall be the crucial date for calculating the experience including the practical experience.

If the applicant possesses an equivalence of qualifications other than prescribed qualification in this notification, applicant should produce a copy of the Government orders to the District Selection Committee, Prakasam District in advance within the last date for submitting application, failing which their application will be rejected.

PARA: 3:: Reservations:

There will be reservations in this recruitment in respect of Scheduled Tribes(ST), Scheduled Castes(SC), Backward Classes(BC), Economically Weaker Sections(EWS), Physically challenged(VH,HH,OH), Women, Ex-servicemen and Meritorious Sports Persons as per Rule 22 and 22(A) of AP State and Subordinate Service Rules 1996.

In the case of candidates who claim the benefit of reservation or relaxation from upper age limit on the basis of Caste/Tribe or Community the basic document of proof of Community will be the certificate issued by the Revenue Authorities not below the rank of Tahsildar in the case of SC/ST/BC/EWS. Subsequent claim of change of Community will not be entertain.

The person with Disability means a person suffering from not less than 40% of any disability as certified by a medical authority except hearing impairment (HH). Hearing Impairment means loss of 60 dB or more in the better ear in the conversational range of frequencies which corresponds to 85 dB hearing threshold on the audiogram in the better ear i.e., 85 dB hearing level in audiogram-25 dB upper limit of normal hearing = 60 dB hearing loss as per provision under "Person with Disabilities Act, 1995".

Caste & Community; Community certificate issued by the Competent Authority in terms of G.O.Ms.No.58, SW(J) Dept., Dt.12.05.1997 should be submitted appropriate time. As per AP State and Subordinate Service Rules, Rule 2(28) Explanation: In so far as claiming for SC reservation is concerned, no person who professes a religion different from Hinduism shall be deemed a member of Scheduled Caste. However, Scheduled Caste converts to Buddhism deemed to be Scheduled Caste. BCs, SCs, STs & EWS belonging to other state or not entitled for reservation.

There shall be reservation to Women horizontally to an extent of 33 1/3 % in terms of rule 22(A) of AP State and Subordinate Service Rules as per G.O.Ms.No.63, GA (Ser-D) Dept., Dt.17.04.2018.

The reservation to Meritorious Sports persons will apply as per G.O.Ms.No.13, GA (Ser-D) Dept., Dt.23.01.2018, G.O.Ms.No.74, Youth, Advancement, Tourism and Culture (Sports) Dept., Dt.09.08.2012, G.O.Ms.No.473, Youth, Advancement, Tourism and Culture (Sports & YS) Dept., Dt.03.12.2018 and G.O.Ms.No.08, Youth, Advancement, Tourism and Culture (Sports) Dept., Dt.23.11.2020.

Evaluation of various Physical Disabilities and procedure for certifications will be as per order contained in G.O.Ms.No.56, WD,CW&DW(DW) Dept., Dt.02.12.2003 and G.O.Ms.No.31, WD,CW&DW(DW) Dept., Dt.01.12.2009.

The reservation to Physically Challenged persons will apply as per G.O.Ms.No.99, GA(Ser-D) Dept., Dt.04.03.2013 read with G.O.Ms.No.23, Women, Children, Disabled & Senior Citizen (DW), Dept., Dt. 26.05.2011.

Reservation to BC-E group will be subject to the adjudication of litigation before the Hon'ble Courts including final orders in Civil Appeal no: (a) 2628-2637 of 2010 in SLP no.7388-7397 of 2010 dt.25.03.2010 and order from the Government.

Economically Weaker Sections (EWS) means the persons who are not covered under existing scheme of reservations for SCs, STs, Socially and Economically Backward Classes and whose gross annual family income is below Rs.8.00 lack or identified as Economically Weaker Sections (EWS) for the benefit of the reservations. The income shall also include income from all sources i.e., Salary, Agriculture, Business, Profession, etc., for the financial year prior to the year of application. The persons seeking the benefit of reservations under EWS category shall obtained the necessary EWS certificate issued by the Tahsildar concerned and produce at an appropriate time to the District Selection Committee, Prakasam District as per G.O.Ms.No.73, GA(Ser-D) Dept., Dt.04.08.2021.

PARA: 4:: Reservation to Local candidates:

Reservation to the local candidate is applicable as provided in Article 371-D as per G.O.Ms.674, GA(SPF-A) Dept., Dt.20.10.1975 and rules amendment from time to time and as in force on the date of notification. The candidate claiming as local candidates should obtain the required study certificates (from 4th class to 10th class or SSC) or Residence Certificate in the proforma prescribed for those candidates who have not studied in any Educational Institutions as the case may be. The relevant certificate with authorize signature shall be produced as and when required.

The definition of Local candidate as per G.O.Ms.674, GA(SPF-A) Dept., Dt.20.10.1975 as follows;

- a. If he/she has studied in an educational institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared for the relevant qualifying examination or
- b. Where during the whole or any part of the 4 consecutive academic year ending with the academic year or as the case may be, first appeared for the relevant qualifying the examination he/she has not studied in any educational institution, if he/she has resided in that local area for a period of not less than 4 years immediately preceding the date of commencement of qualifying examination in which he/she appeared as the case may be, first appeared.
- c. Whether any candidate has resided in local area shall be determined with references to the places where the candidate actually resided and not with reference to the residence of his/her parents or other guardian.
- d. If he/she has studied in educational institute in the state for a period of not less than 7 consecutive academic year ending with academic year in which he/she appeared or as the case may be, first appeared for the relevant qualifying examination be regarded as a local candidate in relation to (i) such local area where he/she has studied for the maximum period out of this said period of 7 years; or (ii) where the periods of his/her study in two or more local areas are equal, such local areas where he/she has studied lost in such equal periods.

Single Certificate, whether of study or residence as stipulated in G.O.Ms.No.674, GA (SPF-A) Dept., Dt.20.10.1975 would suffice for enabling the candidate to apply as a local candidate.

Residence certificate will not be accepted, if a candidate has studied in any educational institution up to SSC or equivalent examination. Such candidate have produce study certificate invariably. The candidates, who acquired degree from open universities directly without studying in any educational institution, only may submit residence certificate. Here educational Institutions mean a recognized institution by the Government/university/Competent authority.

Candidate are advised to refer provisions of Presidential order 1975 in this regard. Candidates who migrates from Telangana to Andhra Pradesh between 2nd June 2014 and 1st June 2021 as per G.O.Ms.No.130, GA(SPF&MC) Dept., Dt.28.10.2019 and as per terms laid down in circular memo no.4136/SPF&MC/2015-13, GA(SPF&MC) Dept., Dt.20.11.2017 of Government of Andhra Pradesh shall obtained the local status certificate from competent authority and produce at the time of submission of application and further verification.

For Zonal cadre posts, the candidates belonging to Prakasam, Guntur, SPSR Nellore Districts (Zone-III) will be considered as 'Local' and the candidates belonging to rest of Zone-III will be considered as 'Non-local'.

For District cadre posts, the candidates belonging to Prakasam District will be considered as 'Local' and the candidates belonging to rest of Prakasam District will be considered as 'Non-local'.

PARA: 5 :: Age :

Minimum 18 years & maximum 42 years as on 01.07.2021 as per G.O.Ms.No.105 GA(Ser-A) Dept., Dt.27.09.2021(no person shall be eligible if less than 18 years and is more than 42 years).

PARA: 6 :: Fee :

Applicant must enclose a demand draft towards application processing fee as given below; (if candidate is eligible for more than one post is required to enclose demand draft for each post and apply for each post separately).

- a) For All candidates.... = Rs.200/-
- b) For Physically challenged candidates.. = Exempted

PARA: 7:: Important note on Recruitment process and procedure of selection:

The recruitment will be processed as per this notification and as per the rules and instructions issued by the Government and also as decided by the District Selection Committee, Prakasam from time to time in terms of respective Special Rules/Adhoc Rules governing the recruitment and the related G.Os, rules etc., are applicable.

The various conditions and criteria prescribed herein are governed by the AP State and Subordinate Rules 1996 read with the relevant special rules applicable to any particular services in the departments. Any guidelines or clarifications are based on the said rules, and in case of any necessity any matter will be processed as per the relevant General and Special Rules as in force.

In terms of para 4 of AP Public Employment (organization of local cadres and regulations of direct recruitment) order 1975 (G.O.Ms.No.675 GA(SPF-A) Dept., Dt.20.10.1975) read with G.O.Ms.No.124 GA(SPF-A) Dept., Dt. 07.03.2002, Govt., Memo no.42005/Ser.D/2002-1 Dt.28.08.2002, the selection list shall be divided in to two parts.

- a) Regarding Zonal cadre posts; the first part shall comprise 30% of the posts consisting of combined merit lists of locals as well as non-locals and the remaining second part shall comprise the balance 70% of the posts consisting of locals only and the posts shall be filled duly following the rule of reservation.
- b) Regarding District cadre posts; the first part shall comprise 20% of the posts consisting of combined merit lists of locals as well as non-locals and the remaining second part shall comprise the balance 80% of the posts consisting of locals only and the posts shall be filled duly following the rule of reservation.

A candidate shall be disqualified for appointment, if he himself/she herself or through relations or friends or any others has canvassed or endeavoured to enlist for his candidate, extraneous support, whether from official or non-official for appointment to this service.

^{**} The age relaxation for Ex-servicemen is applicable for those who have been released from Armed forces other than by way of dismissal or discharge on account of misconduct or inefficiency.

Note-1: The maximum weightage as mentioned at point - (02) for Government service rendered in Tribal/Rural/Urban areas including Covid-19 duties is 15% only.

Note-2: The above Covid-19 shall be applicable only to the persons who have rendered their services for Covid-19 on Contract/Outsourcing/Honorarium basis and are appointed by the District Collectors or any other Competent authority exclusively for Covid-19 purpose, based on orders issued by the Government from time to time.

The claims of members of the SCs, STs, BCs, EWS & Women as the case may be, shall also be considered for the vacancies earmarked for open competition, which shall be filled on the basis of open competition. In respect of social reservations viz., SCs, STs, BCs, EWSs, the vertical reservation will be applicable and the number of appointments reserved for that category shall in no way be affected during the period of reservation for that category is in force. In case of women, the horizontal reservation is applicable in terms of G.O.Ms.No.63, GA(Ser-D) Dept., Dt. 17.04.2018.

Where the candidates get equal number of marks in the selection process if two or more candidates get equal total number of marks, those candidates shall be bracketed. Candidates with the same bracket shall then be ranked 1, 2, 3 etc., according to age i.e., oldest being considered for selection. In case there is tie in age the person who possesses educational qualification for that post at earlier date would be considered.

The appointment of selected candidates will be subject to their being found medically fit in the appropriate medical classification and if he/she of sound health active habits and free from any bodily defect or infirmity.

PARA: 8:: Tenure of appointment and important conditions:

The selected candidates in this recruitment notification **should work for a period of one year** from the date of joining at place of posting; otherwise their candidature will not be considered for further any kind of benefits from the Government.

The tenure of selected candidates in this recruitment notification will be one year from the date of joining and the District Selection Committee; Prakasam reserves all the rights to terminate the contract/outsourcing services of any candidate/candidates at any time without giving any prior notice as per directions of the Government from time to time.

PARA: 9:: Debarment:

Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility is correct in all aspects. Any candidate furnishing in-correct information or making false declaration his/her eligibility at any stage or suppressing any information, is liable to be debarred up to 5 years from applying for any of the notifications conducted by APPSC/District Selection Committee/any other recruiting agencies and their candidature for this recruitment summarily rejected.

The District Selection Committee, Prakasam is vested with conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by anyone causing or likely to cause breach of this duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by DSC, Prakasam will be sufficient cause for rendering such questionable means as ground for debarment and other consequences as per law and rules.

PARA: 10 :: District Selection Committee decision to be final :

10.1. The decision of the District Selection Committee in all aspects and respects pertaining to the application and its acceptance or rejection as the case may be, conduct of recruitment of and at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects and binding on all concerned, under the powers vested with it as per rules in force. District Selection Committee also reserves its rights to alter and modify the terms and conditions laid down in the notification for conducting the various stages up to selection or withdraw the notification at any time as warranted by any unforeseen circumstances arising during the course of this process, or as deemed necessary by the District Selection Committee at any stage.
