How to apply :


Interested candidates may appear for interview with two sets of self attested copies of SSC/10th Standard Certificate or equivalent, Proof of date of birth, BAMS, Diploma, Degree Certificate, Attempt Certificate of BAMS, valid CCIM/SCIM, SC/ST/OBC Certificate and Experience Certificate, etc. along with originals. The candidates should also bring two recent passport size photographs along with proof of residence. The Candidate who is currently in the employment must bring experience certificate (working certificate) and NOC, failing which his/her candidature will be liable to rejection.

Note: Candidates claiming reservation/age relaxation on grounds of belonging to OBC should submit the community certificate in prescribed proforma vide Govt. of India, Department of Personnel & Training OM No. – 36012/22/93-EST (SCT) dated 08-09-93 which is modified vide OM No. – 36033-3-2004 Estt. (Res.) dated 09/3/2004 or the latest notification of the Government of India if any, failing which the benefit of reservation/relaxation will not be given or their applications shall be rejected and no request/correspondence will be entertained.

Terms & Conditions :

1. Candidate should report in the Office of Medical Superintendent, ESIC Hospital, Adityapur from 9.00 A.M to 10.30 AM on the stipulated date. Candidates reporting after 10.30 AM will not be entertained for Walk-in-interview.
2. Vacancies are likely to be change depending upon actual requirement at the time of interview.
3. Application along with exam fee (wherever applicable) should be submitted for each post separately.
4. No TA / DA will be paid to candidates for appearing in the interview.
5. The Medical Superintendent reserves the right to fill up all or not to fill up any vacancy /post.
6. The Medical Superintendent reserves the right to alter the date or cancel the interview.
7. Candidates working in Govt. Service should produce “No Objection Certificate” from their department at the time of Interview.
8. The selected candidates shall have to join duty immediately or the date indicated in the offer of appointment / engagement likely to be issued.
9. The selection is subject to the candidates proving their medical fitness and Verification of their Characters & Antecedents.
10. The appointment shall not offer any right or preferences for regular appointment.
11. No Claim for any service benefit like PF, Pension, Gratuity, Medical Allowance Seniority, Promotion and leave will be admissible.
