Upper Age Limit: Upper age limit is 32years as on 01.05.2022.

Relaxations:The upper age limit will be relaxable for ST candidates by 5 years. For candidates belonging to PwBD category having minimum 40% disability or more will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

Terms of Engagement & Remuneration:

Project Engineer-I will be engaged initially for a period of Three years which may be extended upto a maximum of Onemore year (total Maximum tenure of 4 years) based on project requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs. 40,000/-, Rs. 45,000/- Rs. 50,000/- and Rs. 55,000/- during the 1st, 2nd, 3rd and 4th year of contract respectively.

However, if any candidate has completed three years of tenure as a Trainee Engineer in BEL and has applied for Project Engineer post he/she will be directly inducted as Project Engineer–II. The remuneration of such candidates will be Rs.45.000/- for the 1st year, Rs. 50,000/- for 2nd year and Rs.55,000/- for the 3rd year. The overall tenure will be limited to 3 years only.

Qualification: Full time BE/B.Tech course from reputed Institute/University in the following Engineering disciplines –Electronics/Electronics & Communication/ E&T/ Telecommunication.

Minimum Percentage of Marks in BE/B.Tech:

General/EWS: 55% & above

ST/PwBD: Pass class

Post Qualification Experience as on 01.05.2022 :Candidates should possess minimum two years' relevant industry experience.

The relevant post qualification industry experience shall be in the following areas:

Electronics: Candidates preferred having experience in Surveillance/Information Technology/Network Projects. Preference is given to candidates having relevant certificates in the above mentioned areas.

Please Note:

- i. Candidates possessing Industrial experience only need to apply.
- ii. Academy/Teaching/Research work experience will not be considered as relevant industrial experience.
- iii. Candidate should possess Experience certificates/Documents issued by the previous and present employer clearly indicating period of employment and post held.
- iv. The decision of the Selection Committee with respect to industrial experience will be final. Work experience indicated without supporting documents will not be considered and is liable to be rejected/cancelled without any prior intimation.

SELECTION PROCEDURE:

- Selection will be through a Written Test for shortlisted candidates, followed by an Interview, only for those candidates who qualify in the Written Test. **The venue for the Written Test / Interview will be intimated later.**
- 85% Marks will be allotted for the written test and 15% have for the interview. Candidates who pass the written test will be called for interview in the ratio of 1:5 in the order of merit.
- The names of candidates shortlisted for Written Test/Interviews and final selections will be notified on our Company's website.
- Please note that Written Test/Interview call letters will be sent through email only.

HOW TO APPLY: Interested candidates meeting all the criteria mentioned above, should submit the application in the form appended to this advertisement and send the applications through post, **super scribing on the envelope the post applied for.**

Candidates are required to enter all information correctly in the application form as changes shall not be permitted after forwardal of the application form.

Documents to be submitted at the time of submitting the application:

- i. 10th Standard marks card (as proof of date of birth)
- ii. B.E/ B.Tech. Degree certificate (as applicable). In case of CGPA or credits system of assessments, the candidates are required to indicate the formula for conversion of CGPA/ Credits to percentage in accordance with the respective University norms.
- iii. Final consolidated marks sheet.
- iv. Caste / Community/ Disability certificate in case of candidates belonging to ST/EWS/PwBD respectively. Candidates claiming reservation under any of the above categories are required to submit the certificate in the prescribed format. The formats of various certificates are provided as link to the advertisement.
- v. Post qualification experience certificate/s from previous / current employer. Where current employment certificate is not produced the offer of current employment, latest pay slip and employee ID proof should be compulsorily attached.
- vi. Candidates if working in PSUs/ Govt. organizations should compulsorily submit 'No Objection Certificate' at the time of application or Written Test.

Candidates are required to select SBI branch in the payment option and download & print the challan generated through SBI Collect and deposit the application fee plus applicable bank charges in any SBI Branch. The candidate should ensure to obtain the seal and signature of the bank official. Payment receipt/screen shot should be mandatorily attached along with other enclosures.

Candidates have to enter the "SBICollect reference No." generated after payment, in the Application Form. Fees once paid will not be refunded.

General Instructions:

Selected candidates are required to be covered under the following schemes at the time of joining - Medical insurance scheme for a sum of Rs.2 lakhs and Life Cover scheme for a sum of Rs.5 lakhs per annum. In addition to the remuneration indicated, a consolidated amount of Rs. 12,000/- per year will be paid towards expenses like medical insurance premium, attire allowance, stitching charges, footwear allowance, etc.

The Trainee Engineers who are currently working in BEL prior intimation shall be given to the respective HR department of the Unit/SBU/CSG where the engineer is working. Lateral application for the same post is not permitted i.e. Project Engineers who are presently working in one of the Unit of BEL is not eligible to apply for Project Engineer elsewhere in BEL. If applied, the application will be summarily rejected without assigning any reasons.
