Applications are being invited from amongst the eligible candidates working at ICAR Institutes, Head Quarters/Project Directorates/NRCs etc. for the Technical Assistant (T-3) vacant at this Institute on permanent absorption basis at CIAE, Bhopal. Particulars of the posts & eligibility are detailed below:-

Technical Assistant (T-3) (Laboratory Technician)	01-OBC	Officials who were appointed at entry level post of T-3 (Category-II)  Note:- The employees should have completed five years of service after their initial appointment on the date of notification of calling of applications except in cases where request is on medical/ working spouse grounds or on the grounds of being a single lady (unmarried/widowed/divorced).  For single ladies a minimum period of three years (including two years of probation period on initial appointment) will be applicable before applying for transfer.  (If applied on Medical/ Working Spouse Grounds necessary certificate should be enclosed as per Council's letter dated 19.03.2020.

The above Inter-Institutional transfer will be regulated as per Council's Instructions vide F.No. TS 19(01)/2002-Estt.IV dated 19.03.2020 and amendment in the existing transfer policy of technical personnel of ICAR circulated vide F.No. TS 19(6)/2020-Estt.IV dated 19.03.2021. Candidates of category (OBC/UR/SC/ST) shall be eligible for interinstitutional transfer against DR vacancies meant for UR/OBC.

It is requested that the above vacancy may kindly be circulated amongst the eligible and desirous candidates, working at your Institute/ Regional Stations. Application of those candidates who fulfill the requisite eligible conditions and can be relieved immediately in the event of their selection may kindly be forwarded to this Institute in the prescribed proforma which is enclosed herewith along with the following Documents:-

- Initial appointment letters for the post of T-3 issued by their respective Institutes.
- 2. APAR dossiers for the last five years.
- Necessary certificate if applied on medical, working spouse grounds as per council's letter dated 19.03.2020.
- 4. Caste Certificate of the applicant belonging to SC/ST/OBC/EWS.
- A certificate to the effect that no disciplinary/vigilance case is pending/being contemplated against the candidate.
