(DETAILED GUIDELINES FOR THE POST OF LEGAL CONSULTANT IN THE OFFICE OF THE COMMISSION)

Applications in plain paper as per the enclosed proforma are invited from Retired Judicial Officers in the rank of District/Additional Judge with sufficient experience in dealing with the Service Rules for engagement of one Legal Consultant in the office of the OPSC, Cuttack, on contractual basis. Engagement will be made as per the guidelines issued in GA Deptt. Resolution No.23750/Gen., Dtd.27.08.2014 and Letter No. 14852/Gen Dtd.26.05.2022. The monthly remuneration is to be fixed taking into account the rank/qualification of the said retired officer following F.D.O.M. No. 7022/F, dated 17.03.2018.

ELIGIBILITY CONDITION:

1. Judicial Officers in the rank of District/Additional Judge who have retired from Government service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for engagement as legal consultant. The officer must also be able to read and write oriya.
2. Officers against whom no departmental proceedings or criminal cases are contemplated/pending or who have not been penalised for misconduct during the period for preceding five years of retirement will be eligible for consideration.

TERMS AND CONDITIONS:

1. The above engagement shall be valid for a period of one year on contractual basis or till the post is filled up by a Law Officer in OPSC by direct recruitment whichever is earlier.
2. The engaged officer shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1959 as amended from time to time and shall be liable to be proceeded against for his misconduct, omissions and commissions as per the provisions under OCS (Pension) Rules, 1992 as amended from time to time.
3. Engagement can be terminated at any point of time by the Competent Authority due to unsatisfactory performance by giving one month notice. On the contrary, if the engaged officer so desires to resign he may do so by giving one month's written notice to the Authority competent.

4. On engagement, the retired officer will avail consolidated remuneration only (excluding the pension and T.I.) vide prescribed remuneration structure attached to the Level in the Pay Matrix as given in table below pursuant to F.D.O.M. No. 7022/F, dated 17.03.2018 which excludes the pension and T.I.

5. The Period of such engagement shall not be counted as Government service for the purpose of Pension and any other retirement benefits.
6. The appointees shall be entitled to avail 10 days of leave during a year. In case of absence beyond the 10 days during a year, their consolidated remuneration shall be reduced proportionately.
7. The Competent Authority reserves the right to cancel the selection without assigning any reason thereof.

SELECTION PROCESS:

Applications received within due date will be scrutinised by a Selection Committee and the short listed applicants will be required to appear before the Selection Committee for an interview and selection.

Applications should reach in the office of the Commission on or before 5.30 p.m. of **21st of June 2022.**
