1. REQUISITE MINIMUM EDUCATIONAL QUALIFICATION:

As on the last date of submission of application the candidates must possess a minimum qualification and statutory certificate (wherever required) prescribed for the post as shown against the concerned post in the schedule.

2. EXPERIENCE:

As per the C&R Rules of the company the required experience for each post is shown in schedule. Details of experience to be filled in the application form and copy of the experience certificate to be enclosed.

3. AGE:

Candidates should have attained the age of 18 years and must not be more than 40/45 (as shown in the schedule) years of Age on the last date fixed for receipt of the applications. Proof of Age: Secondary School Leaving Certificate or any other examination declared as equivalent thereof, shall only be accepted.

4. APPLICATION FEE (NON REFUNDABLE):

The application fee prescribed for applying for the said post is as follows:

- i) Application Fee Rs.500+ GST of Rs.90 @ 18% = Total Rs.590/- (Rupees Five hundred ninety only) in respect of Candidate of General Category.
- ii) Application Fee Rs.250+ GST of Rs.45 @ 18% = Total Rs.295/- (Rupees Two hundred and ninety five only) in respect of Candidate of SC & ST Category.
- iii) Application fee as above to be paid through Demand Draft obtained in the name of “ KSMCL Bengaluru ” payable at Bangalore.

Only such applications will be considered against which application fee is paid.

5. SUBMISSION OF APPLICATION :

The application format is uploaded in the company's website www.ksmc.karnataka.gov.in

Candidates are requested to down load and fill up the application and submit it along with their resume and copies of certificates pertaining to their Academic Qualification, Statutory Certificate, Experience, Caste, 371 (J) Certificate (candidate applying for the Local Cadre post) etc, within the stipulated period.

6. SELECTION:

Recruitment for all the above post of Manager (category) will be made by selection strictly on merit as follows:-

An Interview shall be conducted for the short listed eligible candidates for selection to the posts. Shortlisting will be on the basis of percentage of marks secured in qualifying examination, possessing of statutory certificate and prescribed experience. The short listed eligible candidates will be called for personal interview in descending order at the ratio of 1:7. or 1:5 for single post and for more than one post respectively. The total marks assigned for criteria in short listing will be 70 and for interview it will be 30 marks.

7. GENERAL INSTRUCTIONS:

- 1) Only Indian Citizens are eligible to apply.
- 2) No person who has been convicted of an offence involving moral turpitude or who has been temporarily debarred or disqualified by the Union or any State Public Service Commission from appearing for examination or Selections conducted by it shall ordinarily be appointed unless the Company after review of all the circumstance consider him/her suitable for such appointment.
- 3) Application with false information are liable to be rejected. Candidates who obtain appointment by furnishing false information in the application are liable to be terminated and criminal prosecution will be initiated in accordance with law.
- 4) All correspondence will be made against the details furnished in the application Correspondence for change of address, e-mail & mobile number at a later date will not be entertained.
- 5) Candidates must be physically and psychologically healthy and free from the physical deformities affecting in effective management of duties assigned to the post to be appointed.
- 6) Candidate claiming caste reservation will have to produce certificate in the prescribed format as per order/guidelines of Government of Karnataka.
- 7) For the recruitment of posts of Local Cadre Kalyana Karnataka (HK) Region, a candidate shall be regarded as local person as related to local area as specified in the Karnataka Public Employment (Reservation in Appointment for Hyderabad-Karnataka Region) Order, 2013 as notified by Govt. in Sl. No 6 of Notification No. DPAR/06/PLX-2012 dated 06.11.2013 and subsequent amendments from time to time. Candidates should produce relevant certificate as specified as per Govt. Notification –I & II No. DPAR 43 HKC 2013 dated 29.01.2014.
- 8) Original documents /testimonials /certificates /records etc, shall be produced For verification only when called for. Candidates who fails to produce relevant documents will not be considered for selection.
- 9) The candidates who are in Government Service shall submit a No Objection Certificates in Original from their employer at the time of documents verification, failing which their application will be rejected.

- 10) The Company reserves the right to Cancel, amend or alter the Employment Notification during any stage and without prejudice to issue notification, If necessary.
 - 11) No correspondence or enquires will be entertained from the candidates about the recruitment process.
 - 12) Candidates must have the Knowledge of Kannada to read, write and to speak.
 - 13) Candidates appearing for interview will not be paid any TA/DA from the company.
 - 14) The decision of KSMCL in matters relating to eligibility of the candidates will be final and binding.
 - 15) Canvassing in any form for appointment will be a disqualification.
 - 16) Candidates shall satisfy all criteria prescribed for eligibility as on the last date fixed for the receipt of applications.
 - 17) Selected candidates are required to appear before Medical Board to Certify his/her fitness for appointment . The opinion of the Medical authority regarding physical fitness or other wise of the candidates for appointment, shall be binding on the candidate.
