The applicants who desire to apply for appointment to the posts of Notary are requested to follow the instructions and apply in the prescribed Proforma.

P.T.O.,

I. **Qualifications for appointment as Notary.**

No person shall be eligible for appointment as a Notary unless on the date of the applications for such appointment.

- a) A person had been practicing at least for 10 years, or
- aa) A person belonging to Scheduled Castes / Scheduled Tribes and other backward classes had been practicing at least for 07 years, or
- ab) A woman who had been practicing at least for 07 years as a legal practitioner,

(OR)

- b) He had been a member of Indian Legal Service under the Central Government.

(OR)

- c) He had been at least 10 years :

- i) A member of Judicial Service ;
- ii) held an office under the Central Government or a State Government requiring special knowledge of Law after enrolment as an advocate.
- iii) held an office in the department of Judge, Advocate General or in the department of the Armed forces.

II. **Applications for appointment as a Notary.**

- i) The memorial shall be drawn by a person referred to in clause (a) of Rule 3 of Notary Rules, 1956 in accordance with Form-I and by a person referred to in clause (b) & (c) of the said rule in accordance with Form-II (A person applying in Form-II for appointment as Notary may submit the memorial direct to the competent authority).

ii) The memorial of person referred to in clause (a) of Rule 3 shall be signed by the applicant and shall be countersigned by the following persons:

- a) a Magistrate ;
- b) Manager of Nationalised Bank ;
- c) a Merchant ; and
- d) Two prominent inhabitants of the local area within which the applicant intends to practice as a Notary.

III. The duly filled up applications (**in Memorial Form-I**) shall be sent to the **Principal District & Sessions Judge, Ballari**, alongwith the enclosures such as copies of education qualification, proof of eligibility, date of birth, etc., so as to reach this Office before **05.00 P.M** on **03.10.2022**.
