**Note:**

- (1) The maximum age limit for appointment by deputation shall be not exceeding 55 years as on the closing date of receipt of applications.
- (2) For the purpose of appointment on deputation basis, the service must have been rendered on a regular basis by an officer.
- (3) The departmental officers in the feeder cadre who are in the direct line of promotion will not be eligible for consideration for appointment on deputation.
- (4) Persons employed in Private Companies, or in Companies/Organizations other than that mentioned in para 1 above, or unemployed persons need not to apply. Their applications will be summarily rejected.
- (5) The selected officers will be on deputation for a period of one year initially which can be curtailed or extended further, depending upon the requirement, and with the consent of the officer and approval of the lending department. The usual deputation terms will apply.
- (6) All Departments/Boards/Corporations/Universities/CPCB/Public Limited Company of repute are requested to circulate the above posts among the officers, working with them and forward the application (in prescribed proforma) of eligible and interested officers, alongwith a certificate to the effect that they are clear from Vigilance angle, their integrity certificate, details of major/minor penalty imposed on them during the last 10 years and attested photocopies of their ACRs/APARs for the last 5 years to the Member Secretary, Haryana State Pollution Control Board, C-11, Sector-6, Panchkula within 15 days.
- (7) The eligible persons will submit their applications with the NOC of their parent Department positively by 28<sup>th</sup> September, 2022.
- (8) Officers against whom any disciplinary proceedings or vigilance enquiry is pending shall not be eligible, they need not to apply.
