

2. The services of the applicant shall stand terminated automatically on the expiry of the period given in the appointment order.
3. The candidates will have no claim for his/her continuation of service as well as for appointment on the regular establishment in the service/s of KVK, Dudhburdi/MAFSU Nagpur/ICAR
4. The Upper Age Limit is 45 years.
5. Applicant is not required to pay any fees for application.
6. Knowledge of Computer operation is essential for all posts evidenced by passing of MS-CIT or equivalent computer literacy examination.
7. The candidates are required to apply only in the prescribed format of application form and it should be duly signed.
8. There is separate application format for technical posts and other posts, hence candidate should apply using relevant application form.
