- 2. DURATION: Posting is done on contract basis in INSTITUTE OF NURSING SCIENCES AND RESEARCH, MALABAR CANCER CENTRE initially for a period of 179 days and can be extended for a maximum period of 3 years, subject to satisfactory performance.
- **3.** Candidate should apply ONLINE through our website<u>www.mcc.kerala.gov.in</u>. Last Date of Online Application is **07**<sup>th</sup>**October 2022**, **5.00 PM**.
- **4.** Please assure that you have the following before proceeding to Online Registration.
  - Your photograph in digital form with the following specifications:

  - Image dimension: 150W x 200Hpx
  - Image type: jpg format
- 5. <u>Application fee</u>: The application fee shall pay online through the payment gateway system provided in the online Application that is Rs. 50/-(Rupees fifty only) for SC/ST category and Rs. 250/- (Rupees Two hundred and fifty only) for others.
- **6.** Candidates should produce the originals Certificates at the time of Interview.
- 7. Communication of Interview/Test will be only through e-mail. Candidates are advised to visit our website <a href="https://www.kerala.gov.in.regularly">www.kerala.gov.in.regularly</a> for updates/notices and announcements.
- **8.** Age will be calculated as on 1<sup>st</sup> January of the year i.e., **01.01.2022.**
