Mumbai Railway Vikas Corporation Ltd.(MRVC), a Public Sector Undertaking of Govt. of India under Ministry of Railways (MoR), incorporated on 12th July 1999 under Companies Act, 1956, executes the projects under Mumbai Urban Transport Project (MUTP). The Corporation already executed number of suburban rail improvement projects in Mumbai and extended suburbs for enhancing suburban rail transportation capacity. The corporation is also involved in the planning and development of Mumbai Suburban Rail system.

MRVC is looking for dynamic and result oriented candidates for manning the following position for execution of projects in Mumbai Suburban Area on contract basis :

^{*} The panel will be formed for 30, however, as per the present requirement initially 10 Project Engineers (Civil) will be engaged and based on subsequent requirements further candidates from the panel will be engaged as Project Engineers (Civil). The currency of the panel will be for 12 months.

Nature of Appointment

Though the project tenure is for 5 years, the initial appointment will be made for two years on contract basis with consolidated emoluments. The period of contract is extendable by three years with enhanced emoluments, depending upon the project requirements and performance of the candidate.

Consolidated Emoluments

Salary: IDA equivalent E-1 grade Scale Rs.40000 - 140000 with Basic Pay of Rs. 40000/-, applicable DA and HRA @ 27% of basic pay, subject to deduction of statutory or other deductions. Also, other perks and allowances would be admissible as per extant policy of MRVC. Increment @ 3% of basic pay will be granted at the end of one year depending upon their performance and Corporation's requirement.

Eligibility Criteria

Age Limit: Candidate's upper age limit should not exceed 30 years as on 30th September 2022. Age relaxation will be applicable as per the rules.

Educational Qualification:

1	Project Engineer (Civil)	 Candidate should have qualified in the GATE -2022. Bachelor's Degree in Civil Engineering with minimum 60 percent marks from recognized Govt. Universities or Institutions through full time regular courses only.

Engagement Process

Engagement will be made on the basis of scores of Graduate Aptitude Test in Engineering-2022. Based on GATE-2022 score and Organizational requirement, shortlisted candidates will be called for verification of the original documents. In case of more number of eligible applications received, then the candidates equal to 05 times the notified vacancies will be called based on GATE-2022 score. After verification, shortlisted candidates will be given offer of appointment as per vacancy.

Service Agreement Bond

Though the project tenure is for 5 years, the selected candidates will have to serve the Corporation for at least two years for which he/she should execute a Surety Bond of Rs.50,000/-.

Medical Examination

The candidate should have sound health. Before joining, candidates will have to undergo medical examination and provide Medical Fitness Certificate from Government registered medical practitioner. No relaxation in health standards is allowed.

- 2. Candidates should have a valid personal email ID, which should be kept active till the completion of engagement of Contract Project Engineers. MRVC shall send communication calling shortlisted candidates for Document Verification etc. through e-mail only.
- 3. Application should be complete in all respects and as per the prescribed format. Applications not conforming to the prescribed format and without the required documents annexed will be summarily rejected.

General Instructions

- 1. Candidature of a candidate is liable to be rejected at any stage of engagement process or after engagement or joining, if any information provided by the candidate is false or is found to be not in conformity with eligibility criteria mentioned in the advertisement.
- 2. Candidates, if shortlisted for verification of documents and discussions, are required to bring their original GATE 2022 Admit Card and GATE-2022 Score Card, Engineering Graduation Mark Sheet, Engineering Graduation Certificate, SSC Mark Sheet, HSC/Diploma Mark Sheet, Date of Birth Certificate/ID proof, CasteCertificate (If belong to reserved community)., Income and Asset Certificate for EWS, copy of the Application Form and Passport size photograph (photograph should match with the one pasted in the Application Form) for verification with other relevant documents at the time of document verification.
- 3. For EWS (Economically Weaker Section) Candidates:
 - a) Candidates who are not covered under the scheme of reservation for SC/ST/OBC and whose family gross annual income is below Rs. 8.00 Lakh (Rupees Eight Lakh) are to be identified as EWS for benefit of reservation for EWS. The income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application i.e. 2022-2023. Also, candidates whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of family income:
 - i. 5 acres of agricultural land and above;
 - ii. Residential flat of 1000 sq. ft. and above;
 - iii. Residential plot of 100 sq. yards and above in notified municipalities;
 - iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

- b) The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status. The term "family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure –I shall only be accepted as proof of candidate's claim as belonging to EWS:
 - District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner / 1st class Stipendiary Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
 - ii. Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate.
 - iii. Revenue Officer not below the rank of Tehsildar and
 - iv. Sub-Divisional Officer of the area where the candidate and/or his family normally resides.
- 4. The candidates applying against the vacancies reserved for EWS must produce valid Income and Asset Certificate issued by Competent Authority as per **Annexure II** on the date of Document Verification. In case of non-compliance to these stipulations, their claim for reserved status under EWS will not be entertained and the candidature/application of such candidates, if fulfilling all the eligibility conditions for General (UR) Category, will be considered under General (UR) vaccines only.
- 5. Candidates employed with Government Departments / PSUs / Autonomous Bodies have to produce NOC at the time of document verification, failing which they would not be allowed to appear for document verification.
- 6. MRVC reserves the right to cancel / restrict / enlarge/ modify / alter the engagement process, if need so arises, without issuing any further notice or assigning any reason whatsoever.
