

**Terms & conditions**

1. **Emoluments:** The consolidated emoluments for the post will be:
  - i. Rs. 20,000/- per month for first two years and
  - ii. Rs. 22,000/- per month for third year
  
2. **Engagement period:** The post is purely temporary on a contractual basis for duration of 03 years (three years) from the date of joining of the Junior Research Assistant (JRA) under the project. The engagement as JRA shall stand automatically terminated with the project. However, the engagement can be extended in case the project duration is extended by the funding agency subject to satisfactory performance of the candidate.
3. The selected candidate shall not claim regular appointment at this Institute, as the post is temporary and co-terminus with the project.
