In Pursuance to Letter No. HC.VII-33/2018/7257/A Dated 25.08.2022 of the Hon'ble Gauhati High Court, applications are invited in "Standard Form" from eligible candidates who are citizens of India as defined in Articles 5 to 8 of the Constitution of India, domiciled in the state of Assam for filling up the following posts for the proposed "Exclusive POCSO Court (ePOCSO Courts)" in the Chirang district judiciary purely on contractual basis/hiring, for the financial year or till the scheme of ePOCSO Court may be continued by the Govt. at the Centre and the State. The selected candidates/ staff shall join on the day of inauguration of the e POCSO Court in the Chirang district.

Candidate should possess a Diploma/ Certificate in Stenography/ Shorthand from ITI/ Polytechnic or any other legally recognized Institute. Must have adequate knowledge of Assamese language. Retired Staff of Subordinate Judiciary having the aforesaid qualification may also apply.

3.	Office Assistant	02 (two)	Rs. 18,000/- (each)	Graduate in any discipline from any Govt. recognised University. Must have 6 (six) months diploma in Computer application. Retired Staff of Subordinate Judiciary having the aforesaid qualification may also apply.
4.	Driver	01(one)	Rs. 15,000/-	Candidates must have class eight standard from recognized School/Institution having a valid LMV Driving License issued by the Competent Authority. Those who have passed HSSLC (Class XII) or above shall be ineligible to apply for the said post.
5.	Office Peon	2 (two)	Rs. 12,000/- (each)	Candidate must possess the minimum (educational qualification of Class VIII standard, and those who have passed HSSLC (Class XII) or above shall be ineligible to apply for the said post

The last date and time of receipt of application is **15/11/2022 at 4.30 P.M.** No application will be entertained after last date. The appointing authority shall not be responsible under any circumstances of any postal delay.
2. Candidates must submit their application in standard format along with self attested copies of all testimonials regarding Educational Qualification, Age, Caste, Experience Certificate, valid Driving License (for the post of Driver), etc. along with 3 (Three) copies of recent

passport size photographs, duly signed by the candidate on the reverse side and addresses to the office of the District & Sessions Judge, Chirang, Kajalgaon P, O. Kajalgaon, Chirang, Pin-783385, BTR, Assam, through registered post only.

3. Envelope containing the application must be super scribed with the post applied for on the top of the envelope. For e.g. "APPLICATION FOR THE POST OF PEON IN THE ePOCSO COURT, CHIRANG" in block capital letters.
4. Candidates serving in Govt. Department should submit their application through proper channel.
5. If any candidate is found to have suppressed his educational qualifications or to have given wrong information, at the time of applying for job or later on, his candidature shall stand rejected without any information to him with immediate effect and shall also be liable to Criminal Prosecution as per law.
6. Candidates must not be less than 18 years or more than 40 years of age on the last date of submission of application. The relaxation of age shall be applicable as per existing rules of the State Government. In case of retired staff of Subordinate Judiciary, age is no bar.
7. Candidates must mention their Mobile Numbers clearly in the application without fail.
8. Separate applications to be submitted for separate post.
9. Application received late or without proper supporting documents or unsigned or incomplete will be summarily rejected.

The list of eligible candidates/ rejected candidates along with specific dates of written examination, viva voce, skill test etc (as and where applicable) shall be uploaded in the Official website of Chirang District Judiciary (<http://chirangjudiciary.gov.in/>) and in the Notice Board of District & Sessions Judge Office in due course.
