1. The Applicant should have knowledge of Prevention of Cruelty to Animals Act and other Acts related to Animal Welfare Board of India for the post of Field Intervention Officer.
2. The Applicant should have passed 12<sup>th</sup> Class and produce the passing certificate. (Xerox Copy of Certificate to be enclosed).
3. The applicant should have knowledge in English, Marathi, Konkani and Hindi. (Read/Write/Speak).
4. Should have basic computer knowledge. (Xerox Copies of Certificate to be enclosed).
5. The Applicant should have work experience in the subject related matters. (Xerox Copies of Experience Certificate to be enclosed).
6. Should possess valid 15 years residential certificate in the state of Goa issued by the Competent Authority/Mamlatdar. (Xerox Copies of Certificate to be enclosed).
7. Applicant's age should not be below 18 yrs and above 65 yrs as on date of submission of application. Relaxation with submission of Medical Fitness Certificate to above 65 yrs of age.
8. Should possess vehicle (two wheeler) is a must with valid Driving license. (Xerox copy to be enclosed).
9. The Applicant should not have been involved in any illegal litigations or case filed against him / her.

The Applicant's expected remuneration / fees should be within the Government Approved rates as per the "DSPCA – Animal Welfare and Rescue Scheme" notified and published vide Government of Goa, Official Gazette Series I No.30 dated 27<sup>th</sup> October 2022.
