Eligibility Conditions:-

1. Officers who have retired from Government service on attaining the age of superannuation and below the age of sixty-five years having good service records and are physically fit shall be eligible to be considered for re-employment.
2. Officers against whom departmental proceedings or criminal cases are contemplated/ pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.
2. The engagement shall be made initially for a period of one year which may be extended upto a total period of four years not beyond the age of sixty-five years of age in any case or till the posts are filled up by regular process whichever is earlier subject to satisfactory performance. The competent

authority reserves the right to terminate the engagement at any time by giving one month written notice to the appointee. On the contrary, if any re-employed employee desires to resign, he/ she shall do so by giving one month written notice to the competent authority.

3. The retired Officer against whom a vigilance case or Departmental Proceeding or Criminal prosecution is contemplated or pending or who has been penalised for misconduct during the preceding five years of his/ her retirement or is a member of a political party will not be considered for re-engagement.

4. The period of contractual engagement shall not be counted as Govt. service for the purpose of pension and any other retirement benefit. The engaged employee will be subject to and will abide by the provisions to the Government Servant Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.

5. The appointee will furnish an undertaking at the time of joining on duty regarding the truth and correctness of the information furnished by him/ her.

The interested retired Government employees fulfilling the above criteria may apply in prescribed application form along with copies of required documents with specification on the cover "Application for appointment as OSD Stenographer" to the undersigned and **application should reach the undersigned by 5.00 PM, 09.12.2022.**

The competent authority reserves the right to reject any or all applications without assigning any reason thereof.
