Qualifications

M.A. in Counselling/Clinical Psychology is required along with a minimum 2-3 years of experience working in the field in the capacity of a researcher/counsellor. Preference will be given to those candidates who have additional qualifications such as having completed specialized courses in Couples and Family Therapy OR demonstrating direct experience working as a couples/family therapist.
