The post of **DIRECTOR, Advanced Institute for Integrated Research on Livestock and Animal Sciences (AIIRLIVAS)** is equivalent to the cadre of Dean of Veterinary Colleges under Tamil Nadu Veterinary and Animal Sciences University with the following academic qualifications and experience at Academic level 14 with rationalized entry pay of Rs.1,44,200/- plus the usual perks and allowances as applicable to the post of Dean of Veterinary Colleges under Tamil Nadu Veterinary and Animal Sciences University.

- i. **Education:** Basic degree in Veterinary and Animal Sciences with a Ph.D., degree in any branch of Veterinary and Animal Sciences
- ii. **Experience:** A minimum of 25 years of experience in the Department of Animal Husbandry or any other Government organizations including a minimum of 5 years of administrative experience in or above the rank of Assistant Director or 3 years service in academic institutions.  
(Or)  
A minimum of 20 years of total experience in University Research / teaching with a minimum of 5 years service in the cadre of professor. He / She should have a minimum of 5 years of Livestock / Poultry farm based research experience and should have published at least 20 research articles in highly rated scientific journals. Wide citation of the same in International journals is preferable.
- iii. **Tenure:** The tenure of Director of AIIRLIVAS will be **Three years** from the date of joining or completion of 60 years of age, whichever is earlier.
