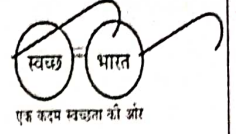

INSTRUCTION TO APPLY

- MODE OF APPLICATIONS:** Application duly completed in all respect will be accepted. Any application form received from any other source shall not be entertained and will be summarily rejected. Application be sent "To The Chief Ececutive Officer, Cantonment Board, 77 MIDDLE ROAD, BARRACKPORE, KOLKATA -700120" under registered post.

Note: Application which are incomplete in any respect, not accompanied by requisite photohraphs, signature, essential qualification and e-challan/receipt of application fee or not properly filled are liable to be summarily rejected. No correspondence in this regard would be entertained by the Board.

2. **Application Fee:** Candidate has to pay application fee of Rs. 500.00 for the post of Lady Doctor. Payment should be made only through internet banking/credit card/debit card etc to Cantonment Board Account, SBI A/C No.11278715400, ISFC Code-SBIN0000029. Any other mode shall not be accepted.
3. **Qualification:** i) Essential: MBBS from a MCI recognised Medical College/University ii) Permanent Registration with MCI or a State Medical Council
Desirable: i) Recognised Post Graduate qualification in General Medicine/ Pediatrics/Pulmonary Medicines like MD/DNB/DCH/DTCD. Preference will be given to the candidates having qualification in DGO, MS Gyno.
4. **AGE:** Age shall be counted from the prescribed last date of receipt of application. Age relaxation to ex-servicemen is as per rules. No age relaxation will be given to other categories as the said post is unreserved. Only valid proof of age i.e Birth Certificate issued by a Competent Authority or School leaving Certificate of Class 10th will be accepted. Prescribed last date of receipt of application shall be 27.12.2022. The cut-off date for determining the age shall be counted from the last date of receipt of application.
5. **Mode of Selection:** The recruitment for the post shall be based on personal interview. Intimation for interview shall be sent separately to all eligible candidates. Candidates are required to visit our website barrackpore.cantt.gov.in regularly to check any information or any amendments or updates regarding said recruitment and time schedule for interview.
6. At the time of interview, candidates are advised to bring all related documents to substantiate their claim regarding DOB, Identity proof, educational qualification, MCI registration etc. in original as well as 02 sets of photo copies of each document. Candidates are also advised to bring recent passport size photographs alongwith Admit card.
7. **Eligibility Criteria:**
 - i) The candidate must be a citizen of India.
 - ii) Qualification acquired by the candidates should be strictly in accordance with the prescribed qualifications as mentioned above in table and the candidate should not seek claim equivalent of their qualification with that of the prescribed qualification.
8. **GENERAL CONDITIONS:**
 - i. The candidate shall be held responsible for correctness of all information given by him/her and in case of any information/documents found to be incorrect at a later stage; action shall be taken against the candidate including dismissal from service.
 - ii. The Cantonment Board, Barrackpore is an autonomous / statutory local body under the Ministry of Defence, Government of India and employees of the Board are governed by CFSR, 1937 & Cantonment Board Employees Service Rules, 2021 as amended from time to time and Govt. instructions issued from time to time shall apply.
 - iii. The above posts are on permanent basis and probation period will be 02 yrs as per rules. The above vacancies are tentative in nature and are subject to change.
 - iv. No correspondence in regard of appointment will be entertained.
 - v. No representation on any grounds for non-appearance for the interview, etc. by the candidates will be entertained and his /her candidatures will not be considered in such an eventuality.
 - vi. Persons already employed should send applications through proper channel and have to produce 'No Objection Certificate' from their present employer at the time of submission of documents.
 - vii. The candidate should not have been convicted by any Court of Law.
 - viii. TA/DA will not be admissible for attending the interview as the case may be.

- xi. Age relaxation will be admissible to the Departmental Candidates of the Cantonment Board, Barrackpore as per rules.
- xii. Categories of disable persons suitable for the job can also apply. But, no age relaxation would be given as the post is unreserved.
- xiii. The cut-off date for determining the age shall be counted from the last date of receipt of application.
