**Selection Criteria for Senior House Physician Cum-Registrar as per Ref.  
No.SVP/1024/83/2012, Dated 24.01.2012**

**CRITERIA**

- 1) Completion of BAMS degree from any recognized university.
- 2) Completion of 1 (one) year housemanship (internship) in any Ayurvedic Institution.
- 3) Completion of 6 months junior house physicianship at any Ayurvedic Institution.
- 4) Knowledge in basic computer.
- 5) Preference will be given to the candidates with M.D.(Ay.) in Kayachikitsa degree.
- 6) Preference will be given to the candidates those who have completed 6 months Senior house physicianship in Kayachikitsa.
- 7) Selection will be made on the basis of merit (A) Marks in Kayachikitsa and (B) if necessary aggregate marks.
- 8) The tenure of the post will be minimum for six months and in no case it will be extended after two (2) years.

**Selection criteria for Senior House-Physician of IPGAE & R at SVSP, Kolkata as per No. DAY/121/97/1 (3), Dated 20.01.1997.**

- 1) Completion of one year Junior House Physicianship and at least 6 months in the particular institution.
- 2) Tenure of Senior House Physicianship will ordinarily be for 16 months and in no case anybody would be considered after one year.
- 3) Selection will be made on the basis of performance and merit.
- 4) Senior House Physicianship must be residential. Female candidates should also be eligible for Senior House Physicianship.

**Selection criteria for Junior House-Physician of IPGAE & R at SVSP, Kolkata as per No. DAY/121/97/1 (3), Dated 20.01.1997**

- 1) Completion of one year Internship.
- 2) Tenure of Junior House Physician-ship will ordinarily be for one year and for first instance for six months.
- 3) The candidates terminated due to genuine ground by the authority of the Institution would not be considered in any case in any Institution.
- 4) The candidates who have already served as Senior House Physician in any Institution will not be considered in the post of Junior House Physician in any Institution.
- 5) House Physicianship will be made on the basis of performance only and in no case any candidates would be considered of the one and half year in the particular institution.
- 6) During selection candidates who are relatively fresh (Year of passing) will be given priority.
- 7) During selection the candidates who performed Junior House Physicianship in short duration will be given priority.
- 8) In case of the preference will be given to the candidates those who have completed Junior House Physicianship in Kayachikitsa and /or secured high marks in Kayachikitsa. Falling which aggregate of the final year marks will be considered.
- 9) House Physicianship Certificate from the head of the Institution last attended will be taken into consideration during selection.
- 10) In case of suppression of facts and submission of false statements candidature will be treated as cancelled without any intimation and the facts will be intimated to the appropriate authority for appropriate action and future record.
