- 1. The Institute reserves the right not to fill up the posts, cancel the advertisement in whole or in part, without assigning any reason and its decision in this regard shall be final.
- 2. The number of posts may increase or decrease and Institute reserves the right not to fill any post.
- Detailed educational qualifications, experience, and other criteria for selection shall be according to the recruitment rules for Faculty in NITs as per Schedule E of the first statutes of the NITs (amendment statutes 2017) issued vide No. 651 Gazette of India dated 24th July 2017, and clarification issued by Ministry of Education dated 16<sup>th</sup> April 2019.
- 4. Prescribed minimum qualification and experience for faculty positions are given in Annexure-I. In case of any discrepancy, the recruitment rules for the post of Assistant Professor shall be followed hence candidates are requested to refer recruitment rules before applying for the post. Recruitment rules are available on Institute website. Preferred areas of specializations in various departments are given in Annexure-II. Faculty members presently employed at NIT Uttarakhand may apply in their specialization. The last date for determining the eligibility in respect of age/qualification/experience shall be 12.01.2023.

- 5. Candidates applying for more than one Department are required to submit separate application forms. Also, candidates applying for more than one pay level (AGP) in any department are required to submit separate application forms.
- 6. The each application must be accompanied by non-refundable Application Fee of Rs. 1000/-. The Application Fee should be remitted Online only (online payment option is available in online Application Form) and the proof of depositing of fee should be submitted along with print out of online application. Indian nationals applying from abroad can apply with a non-refundable application fee of Rs. 5000/- or US\$ 61.

The candidates who had applied against the Advertisement No.10/2019 have to apply again. Fee relaxation will be granted to the candidates after submitting proof of payment of application fee against Advertisement No.10/2019. Please write applicant name on the 'Receipt' before attaching it to the print out of downloaded online application.

The non-refundable Application Fee for SC/ST/Women/Divyaang candidates is Rs. 500/-.

For internal faculty members of NIT Uttarakhand, non-application fee will be Rs. 500/- which will be non-refundable. For this they must apply only using Institute mail ID for registering on the portal.

- 7. Reservation policy will be as per Govt. of India norms. Candidates belonging to SC/ST/OBC (non-creamy layer)/EWS categories should attach a photocopy of the certificate obtained from Revenue Authorities not below the rank of Tehsildar or from a First Class Magistrate of the place of domicile of the candidates clearly authenticating the category to which they belong. Non-creamy layer OBC certificate / Income and Asset Certificate for EWS shall be obtained on or after 01/04/2022. The PwD category candidates should attach photocopy of the certificate obtained from Medical Board concerned including the percentage of their infirmity. Candidates must also clearly indicate the category to which they belong in the application form. Persons with disability having percentage above the minimum specified by Government of India shall only be eligible for the benefit of reservation. For the purpose of reservation of post, the Institution will be regarded as one unit.
- 8. Besides the basic pay in the applicable pay level of the respective positions, admissible allowances like DA, TA, etc. are payable in accordance with Central Government / Institute Rules in force from time to time. Fresh appointees will be covered under the New Pension Scheme (NPS) as per Government of India rules.
- 9. Period of probation will be one year, which may be extended depending on the performance during the first year.
- 10. Fresh appointment beyond the age of 60 years is discouraged except in the case of faculty with exceptionally brilliant research career and with on-going or approved externally funded research project.

- 11. Mere fulfillment of the required qualifications and experience does not entitle a candidate to be called for interview / selection.
- 12. The Screening Committee shall shortlist the eligible and most desirable candidates to be called for interview from amongst the applicants, based on specialization, availability of candidates, and requirements of the departments.
- 13. The Institute reserves the right to restrict the number of candidates for interview to a reasonable limit on the basis of qualifications, experience, and credit points higher than those prescribed in this advertisement or through a written test. All such notifications will be placed on Institute website.
- 14. Canvassing in any form will disqualify the candidature of the applicant.
- 15. More than six months of experience in regular position in Institution of repute or any organization with a pay scale, will only be considered towards qualifying experience. Experience rendered on part-time, daily wages or as visiting faculty will not be counted as experience.
- 16. All Degree Certificates should be from recognized Universities / Institutes. Candidates should have first class degree from Bachelor's Degree onwards.
- 17. Candidates presently employed must apply through proper channels OR shall provide "No Objection Certificate" while applying or at the time of Interview failing which they will not be considered for interview.
- 18. Candidates will have to appear for the test and/or interview at their own cost, if called before the Selection Committee, which will be separately notified to the candidates.
- 19. Selected candidates should be prepared to join duty within the time granted.
- 20. No correspondence whatsoever will be entertained from candidates regarding the reason for not being called for interview / outcome of interview.
- 21. The candidate is responsible for the correctness of the information provided in the application. If it is found, at a later date, that any information given in the application is incorrect / false, the candidature / appointment is liable to be cancelled / terminated and suitable legal action can be taken against his/her.
