TERMS & CONDITIONS

- 1. Age is subject to the existing rules of the State Government.
- Application in standard form together with self attested copies of all the testimonials such as Education Qualification Certificate, Mark Sheets, Age proof Certificate, Caste Certificate, Certificate relating to the special skill etc. should reach the office of the Chief Judicial Magistrate, Darrang, Mangaldai during office hours on working days on or before 03.02.2023
- The candidate who intend to submit their application by hand directly shall drop their application in the drop box in the office of the Chief Judicial Magistrate, Darrang, from 10:00 AM to 5:00 PM in working days from 19.01.2023 to 03.02.2023.
- 4. No application will be entertained after scheduled date for receiving the application. The authority shall not be responsible for any postal delay.
- 5. If any candidate is found to have suppressed his education qualification or given any wrong information, at the time of applying for the post or later on, the candidature shall stood rejected without any information to him with immediate effect and shall also be liable to criminal prosecution as per law.
- 6. Candidates will have to superscribe the post applied for at the top of Envelope in Block Letter.
- 7. Application must be accompanied by 3 self attested copies of recent passport size photographs.
- 8. Candidates already in service shall apply through proper channel.
- 9. Valid Employment Exchange registration number is mandatory for those who are not in service. The candidates shall have to mention the Employment Exchange registration number and date in the application.
- 10. Candidates must mention their contact details clearly including mobile number.
- 11. Incomplete application will be summarily rejected.
- 12. No T.A/ D.A is admissible for attending interview/ test/exam.

- 13. The Authority will not undertake detailed scrutiny of applications for the eligibility and other aspects at the time of written examination and, therefore, candidature will be accepted only provisionally. Candidates must go through the requirements of educational qualification, experience, age, physical and medical standards etc. and satisfy themselves that they are eligible for the post(s). The certificates/documents in support of their Educational Qualifications and Caste/Category, etc. shall be sought at the time of Document Verification by the Authority. Physical and medical standards will be ascertained by the Authority after the declaration of result. Candidates may also note that they would be required to submit their certificates/ documents of EQs/ caste/ category, etc. as and when sought by the Authority. After scrutiny of the certificates/ documents of EQs/ caste/ category, etc., if any claim made in the application is not substantiated by certificates/ documents, the candidature of candidate will be cancelled.
- 14. Mode of selection in respect to the said post shall be through below mentioned processes:-
 - (i) Written examination of 50 marks comprising of Multiple Choice Questions (MCQ).
 - (ii) Candidates in the ratio of 1:10 will be called for the viva voce i.e. the top 10 candidates of the written examination will be called for the viva voce.
 - (iii) Viva voce shall be of 50 marks.
 - (iv) Final results will be decided based on the total marks obtained in the examination and viva voce.
- 15. The list of eligible candidates along with specific date of written exam/ interview shall be uploaded in the official website of Darrang Judiciary (https://darrangjudiciary.gov.in) in due course. No separate cal letter shall be issued. Applicants are requested to refer to the official website.
- 16. Canvassing directly or indirectly will disqualify the candidate for the post.
