#### 8. Mode of Selection: -

- i. For Midwife post: The selection and merit will be based on written test only. (The written test will be of 100 marks of Objective Type Questions having duration of 120 minutes). Answers to the questions will have to be marked on OMR Answer sheet. The written test will be conducted in English and Hindi only.
- ii. For Electrician & Motor Pump Operator posts: The selection and merit will be based on written test (The written test will be of 100 marks of Objective Type Questions having duration of 120 minutes). Answers to the questions will have to be marked on OMR Answer sheet. The written test will be conducted in English and Hindi only.

The qualifying criteria/passing mark/qualifying marks in written test will be set by appointing authority. Candidates who will obtain the qualifying/passing marks in the written test will be considered for final ranking of selection as per marks obtained/secured by them in Written Examination.

There will be a Skill test for the post of Motor Pump Attendant and Electrician which will be only of qualifying nature. The marks of skill test will not be considered for preparing the final merit list. However, the shortlisted candidates in written test will have to secure minimum 50% of marks in skill test of Basic technical skill in the respective Trade, conducted in this phase to qualify for the final merit list.

- **For RMO (Doctor) Post:** The selection and merit will be based on written test followed by Interview of total 100 Marks (The written test will be of 80% marks of Objective Type Questions having duration of 120 minutes). Answer to the questions will have to be marked on OMR Answer sheet & 20% marks of Interview. The written test will be conducted in **English** only. The final Selection of RMO will be based on both written and interview.
- iv. Candidates should note that there will be penalty (negative marking) for wrong answers marked by a candidate in the Objective Type Questions. There are four alternatives for the answer to every question. For each question for which a wrong answer has been marked by the candidate, one-forth (0.25) of the marks assigned to that question will be deducted as penalty. If a candidate marks more than one answer for single question, it will be treated as a wrong answer even if one of the marked answers happen to be correct and there will be same penalty as above for those questions. If a question is left blank i.e., no answer is marked by the candidate, there will be no penalty for that question.

# 10. General Conditions/Instructions/Information:

- The applicant must be a citizen of India.
- b. The service of the appointed candidate / person will be governed under Cantonment Board Employees Service Rules 2021, Cantonments Act 2006 and Central Civil Service (Pension) Rules 2021 as amended from time to time by the Central Government as are applicable to employees of Cantonment Board.
- c. Qualification acquired by the candidates should be strictly in accordance with the prescribed qualifications and the candidates should not seek claim equivalent of their qualification with that of the prescribed qualification.
- d. No request for change of any entries or part, originally indicated in the application form shall be entertained.
- e. The candidates should mention a valid email ID and a working Mobile Number in application form. The candidates are advised not to change the email ID or Mobile Number during the process of recruitment. They are also advised not to give email id / mobile number of any unknown person to avoid any complications.
- f. The candidates shall be held responsible for correctness of all information given by him / her and in case of any information / documents found to be incorrect at a later stage; action shall be taken against the candidates including debarring the candidate / dismissal from service.
- g. No correspondence in regard to the appointment will be entertained.
