1. **Name of Posts:** Lecturer in Government Nursing Colleges under Medical Education & Research Department.

2. **Number of Post:** 10 (Ten) Posts. The number of vacancies may vary due to administrative exigencies in due course of time.

3. **Scale of Pay:** Rs. 57,700/- to Rs. 1,82,400/- PM (Academic Level-10) plus other allowances as admissible under Rules.

4. **Age:** A candidate should not be less than 21 years and not more than 38 years of age as on 01/01/2023.

The upper age limit is relaxable by (if applicable)-

i. 5 years for SC/ST candidates i.e. upto 43 years

ii. 3 years for OBC/MOBC candidates i.e. upto 41 years as per Govt. notification No. ABP.6/2016/9 dated 25/04/2018.

iii. For Persons with Disabilities (PWD) by 10 years irrespective of SC/ST/OBC and General Category of candidates as per Govt. Notification No. ABP.144/95/121 dated 28/10/2015.

6. Weightage shall be given to candidates presently serving under Rule 17A of MHRB Regulations or any contractual engagement under any health care institute under Medical Education & Research Department.
7. Willing and eligible incumbents serving under the Directorate of Health Services (DHS), Assam and other Govt. Agencies will be eligible to apply and no separate NOC from the State Govt. will be required to apply for these posts.
8. **Process of Recruitment:** The selection procedure will be notified later on by issuing addendum. The Board will decide the procedure for selection in respect of the posts on the basis of the number of applications received.
9. **Application fees:**  
Application must be accompanied with required application fee of Rs. 250/- (rupees two hundred fifty) only for General category candidates and Rs. 150/- (rupees one hundred fifty) only for OBC/MOBC/SC/ST (P)/ST (H) candidate.  
No application fee is required for candidates having BPL certificate and PWD certificate.  
Application fee should be deposited only, through Treasury Challan in the Head of Account "0210-Medical and Public Health-01-Urban Health Services-800-Other Receipt". The fees are not refundable and no other mode of deposit of fee other than through Treasury Challan, shall be accepted.

- Fees can be deposited online using Government Receipt Accounting System-GRAS (Website: <https://assamegras.gov.in>). Candidates may pay the requisites fees (as admissible for the category mentioned above). Printed copy of Treasury Challan generated through GRAS should be submitted at the time of interview. In Remarks column, candidate may write the post applied for.
10. **Process to Apply:**
    - a. To apply online visit <https://nhm.assam.gov.in> -> Recruitment -> **Medical and Health Recruitment Board, Assam.**
    - b. Candidates must use their mobile number and password to login.
    - c. After that, candidates can fill up the form for that given post.
    - d. **Once you have submitted the form, no further changes will be applicable.**
  11. **Terms and Conditions:**
    - i. Candidates need not submit any testimonials/certificate at the time of submission of online application. However, candidates have to produce their original testimonials regarding educational qualification, date of birth, caste, PWD, Treasury challan, working experience etc. along with the application form, at the time of interview. Self-attested copies of all testimonials/certificates will have to be submitted to the Board at the time of interview.
    - ii. Application form, which is incomplete in any respect, such as, without photograph and signature, is liable to be rejected summarily.
    - iii. Only those candidates who fulfill all the terms and conditions of the advertisement in respect of the post for which they are applicants shall be entertained. Others need not apply.
    - iv. The Candidates who are already in Corporations/boards/ or in private employment, may apply with intimation to present employer. They shall have to produce "No Objection Certificate" from the present Employer at the time of document verification, before Viva-Voce/Interview and they will have to submit release order at the time of joining.
