- 6) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project.

- 7) The results of the final selection will be placed on ICMR-NIN and ICMR websites. No intimation will be sent by e-mail or phone.
- 8) The recruited project staff is eligible for leave as per project recruitment rules/guidelines and will have to give an undertaking before joining.
- 9) At the time of joining duty, the candidates should bring all original certificates of educational qualifications (from SSC onwards), No Objection Certificate from present employer (compulsory), Experience, Aadhaar Card, Community and PWD Certificate (if applicable) for availing age relaxation, passport size photograph along with one set of photocopies of the certificates duly attested (can be self attested) for verification.
