The corridors being developed under RRTS Phase-1 are **<u>Delhi-Ghaziabad-Meerut</u>**, **<u>Delhi-Gurugram-SNB-Alwar</u>** and **<u>Delhi-Panipat</u>**. Once operational, RRTS will be the fastest, the most comfortable and the safest mode of travel in the NCR.
