## AGE LIMIT:

The minimum and maximum age limits for candidates to make application to these posts shall be as prescribed in the KCS(General Recruitment) Rules and as amended from time to time.

Age limit is not applicable to the in-service candidates of UHS, Bagalkot as per Cadre & Recruitment Rules of UHS, Bagalkot.

## QUALIFICATIONS:

### PROGRAMME ASSISTANT (LAB TECHNICIAN):

- A Bachelor's degree in Horticulture / Agriculture / Agricultural Mktg. & Co-operation / Sericulture / Home Science / Agril. Engineering / Veterinary Science / Animal Science / Forestry / Food Technology / Agriculture Biotechnology from a recognized Horticultural / Agricultural University with good academic record with a minimum OGPA of 6.50/10.00 or CGPA of 2.25/4.00 or its equivalent or 55% of marks (where grade points are not in vogue).
- A relaxation of minimum OGPA from 6.50/10.00 to 6.00/10.00 and CGPA of 2.25/4.00 to 2.00/4.00 is provided for SC/ST category & Physically / Visually disabled persons (55% to 50% of marks where grade points are not in vogue).

## **DRIVER (LIGHT VEHICLE):**

- a) Must have passed SSLC.
- b) Must have a light vehicles driving licence.
- c) Must have experience of not less than 2 yrs. in driving light vehicle excluding the period of Learner's Driving Licence.
- d) Must have a record of good service.

**Note :** For in-service candidates working on regular / MRE's in UHS, Bagalkote attending driving work, 7<sup>th</sup> standard is the minimum qualification.

## **GARDENER:**

- a) Must have passed S.S.L.C.
- b) Minimum of ten months training in Horticulture / Agriculture or related vocational Courses.

## **INSTRUCTIONS TO APPLICANTS:**


1. The entire Notification along with the Application pro-forma prescribed for each of the categories of the posts notified is accessible from the University website <https://uhsbagalkot.karnataka.gov.in> of the University of Horticultural Sciences, Bagalkot.
2. The applicants have to obtain the application pro-form and **Bank Challan** through the University website only. The following processing fees should be paid through the challan at any Branches of **STATE BANK OF INDIA**. The applicants have to enclose **University Copy of the Challan** along with the applications form after payment of processing fees at any Branches of State Bank of India, and to be sent to the **Registrar, UHS, Udyanagiri, Bagalkot-587104**.

**Processing fee for the above posts :** For General Merit candidates (Rs. 600/- only)  
For 2A/2B/3A/3B candidates (Rs. 300/- only)

Applications without processing fees will be rejected. Processing fees will not be returned in any case. DD / IPO / Cheque are not accepted.


3. SC/ST/Cat-I/Ex-servicemen or children of defence personnel killed or disabled in action and Physically Disabled persons are exempted from the payment of processing fees provided they have to furnish the appropriate certificate along with the filled-in applications in support of their claim.
4. **The filled-in applications which do not accompany the prescribed processing fees (University Copy of the challan) are liable to be rejected.**
5. The roster prescribed for the posts notified herewith is in accordance with the Karnataka State Government Orders and as amended from time to time.
6. The applicants belonging to General category, who claim reservation under Rural Quota, have to produce a certificate issued by the competent authority confirming that they do not come under the purview of "**creamy layer**" in the prescribed form, while submitting the application form, as per the Government Order No: ಸಕಇ 225 ಬಿಸಿಎ 2000, ಬೆಂಗಳೂರು ದಿನಾಂಕ: 30ನೇ ಮಾರ್ಚ್ 2002.

7. As per the Government Order dated 03.10.2015, in case of non-availability of suitable /eligible applicants for the posts earmarked for OBCs (i.e., Cat-I, 2A, 2B, 3A, 3B) the respective posts will be carried forward as Backlog and these posts will be carried forward to the future Notification.
8. Further, in case of non-availability of candidates belonging to the special categories under horizontal reservation such as Rural, Woman, Kannada Medium & Ex-servicemen categories, the posts earmarked for the said categories shall be filled-up by other candidates belonging to the respective reservations as per the provisions of the Government Orders.
9. No applicant for any post shall be eligible for the appointment, if he / she is, at the time of his / her application, in permanent employment in any other Department of Government or any other State Government or Central Government or Quasi Government or any other University and has made the application without the consent of the Head of the Department or of the Government or Head of the University, as the case may be, under whom he / she is employed. Accordingly, candidates already in service (Government / Quasi Government or Private) should submit their applications through their Controlling Officer as indicated at supra. Candidates anticipating any delay in sending their applications through the proper channel may submit advance copy of the application within the prescribed last date along with the processing fee. The original application duly forwarded by the parent office must reach this Office within the date of practical / skill/written test/interview or such candidates shall have to produce "**No Objection Certificate**" from their employer on the date of practical/skill/written test/interview, failing which their candidature will be rejected & will not be permitted to attend the practical / skill/written test or interview.
10. The detailed Mode of recruitment for the aforesaid posts are in accordance with the University Notifications displayed in website <https://uhsbagalkot.karnataka.gov.in>.
11. Knowledge of reading and writing Kannada is desirable.
12. The candidates who have studied under Trimester System and other than 10 point grading system are required to produce the equivalent percentage certificates obtained from the respective University.
13. Applications must be accompanied by **ATTESTED COPIES** of Marks Sheets, Certificates, Experience Certificates, Publications, Research Notes, Certificates of Awards/Medals, Certificates related to the past services, etc., and the details of research or related publications, if any, in support of the eligibility.
14. The candidates have to enclose their marks cards of all years / all semesters of SSLC / PUC / concerned Bachelor's & Master's Degree, and any other higher qualifications, if any.
15. All communications, in respect of applications for recruitment against the posts advertised by the University should be addressed to the **Registrar, University of Horticultural Sciences, Udyanagiri, Bagalkot-587104 (Karnataka)**.
16. The vacancies now notified are provisional and are subject to variations. The University reserves the right to fill-in any or all the vacancies.
17. No person shall be appointed to any post/s in the University unless the appointing authority is satisfied that the selected candidate is of good character, and is in all respects suitable for the appointment to the University service.



18. Applications / any other documents received after the last date, and also incomplete applications will be rejected. The University is not responsible for the postal delay.
19. Furnishing any false information or suppression of the facts in the application form shall hold the candidate liable to action deemed fit.
20. Filled-in applications together with copies of the testimonials should also be sent in an envelope, superscribing on it, "**APPLICATION FOR THE POST OF THE**  
**HORTICULTURAL SCIENCES, UDYANAGIRI, BAGALKOT-587104 (KARNATAKA)**" to **THE REGISTRAR, UNIVERSITY OF HORTICULTURAL SCIENCES, UDYANAGIRI, BAGALKOT-587104 (KARNATAKA)** on or before **1.00 p.m. on 04.02.2023** from the candidates staying in India and abroad. The candidates staying abroad may also download the application pro-forma from the University website (<https://uhsbagalkot.karnataka.gov.in>) and submit the application form along with the relevant documents and the prescribed processing fees in the foreign currency.
21. The candidates have to attend the interview/test at their own costs.
22. No recommendation should be forwarded to the University. Canvassing in any form amounts to disqualification for the candidature.
23. The selected candidates are liable to be transferred anywhere in Karnataka to the Colleges/Research Stations/Extension Centres etc., coming under the University jurisdiction.
24. The selected candidates will be coming under the "**New Pension Scheme**" as per Government Order No. FD(SN) 04 PET 2006, dated 31.03.2006 and as amended from time to time.
25. The Selected candidates are compulsorily required to serve in the University of Horticultural Sciences, Bagalkot for a minimum period of Five years, and they have to execute a bond to the said effect.
26. The appointment of the selected candidates is subject to the verifications of the Category Certificates, Academic qualifications, and other certificates issued by the Competent Authorities.
27. The selected candidates have to produce a "**Police Verification Certificate**" issued by the Competent Authority. If the Police Verification Certificate reveals that the candidate is involved in any criminal case or is involved in act which attracts moral turpitude will result in cancellation of his/ her selection. However, the production of Police Verification Certificate is not mandatory for candidates who are already in regular services of Government / Statutory Bodies / Universities / ICAR Institutes.
28. Working hours of the University is 09.00 a.m. to 05.00 p.m. (on Saturday: 09.00 a.m. to 01.00 p.m.).
29. The appointed candidates are governed by the Rules and Regulations of the University of Horticultural Sciences, Bagalkot.
