Subject: Preparation of Panel appointment as Intelligence Officer on **Deputation** basis in the Directorate General of Goods & Service Tax Intelligence, Hyderabad Zonal Unit, Hyderabad.

The Directorate General of Goods & Service Tax Intelligence, Hyderabad Zonal Unit (DGGI, HZU, Hyderabad), is in the process of drawing a panel of willing and suitable officers for filling up the existing vacancies (**01 post**) in Hyderabad Zonal Unit in the grade of Intelligence officer on **deputation basis**.

2. It is proposed to fill up the vacancies by appointing willing and suitable officers on Deputation basis, for a period of five years, from the grade of Inspector. The officers who have been granted financial up-gradation under MACP scheme are also eligible to apply.

3. It may be made clear to the willing officers that the option once given would be final and in the event of selection, he/she will not be allowed to withdraw the option and they are expected to serve DGGI, HZU till the expiry of their tenure.

4. The selected officers, while working in the Directorate General of Goods & Services Tax Intelligence on deputation basis, will be entitled for Deputation Allowance as admissible in terms of Ministry of Personnel, Public Grievances and Pensions, DoP&T, O.M No. 2/22(B)/2008-Estt. (Pay.II) dated 03.09.2008 (as amended) read with DoP&T OM. 2/11/2017 Estt (Pay-II) dated 24.11.2017. The officer, who is selected, however, will have to make his/her own arrangements for residential accommodation.

5. Normally, the deputation is for a period of five years for post of Intelligence officer.

6. Further, as per para IV of Ministry/s F.No. A-35017/28/92-Ad.III-B

dated 30.06.94 officers posted in certain charge/organizations/assignments are required to complete the "Cooling off period" of not less than two years before posting in DGGI. However, the concerned Pr. Chief Commissioners/Chief Commissioners have been given the power to relax the Cooling off period.

7. It is requested that the circular may be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this Zonal Unit. While forwarding the name of the willing officer, the following formation in respect of him/her may also be sent for evaluation by this Directorate:

- (i) Complete Bio-data and willingness of the officer.
- (ii) History of Posting
 - (iii) ACR/APAR grading for the last 05 years duly verified and attested by the Additional/Joint Commissioner..
- (iv) Vigilance Clearance Certificate.
 - (v) No objection certificate from Chief Commissioner's office to relieve in the event of officer's selection.
 - (vi) Pr. Chief Commissioner's/Chief Commissioner's concurrence and permission to relax the "Cooling off period, wherever necessary.

8. In case, while working in the Directorate, if the conduct and work of the officer is not found satisfactory, the officer shall be reverted to their parent Commissionerate prematurely without assigning any reason.

9. The last date for receipt of application is **28.02.2023**.
