ENGAGEMENT OF FINANCIAL LITERACY COMMUNITY RESOURCE PERSON (FLCRP)

TERMS & CONDITIONS

Financial Literacy Community Resource Person (FLCRP): To conduct FLCs and to drive FI activities as part of Viability Plan a team of 25 to 30 young people to be engaged.

Eligibility:

- 1. Graduate
- 2. Should have a two wheeler and driving license to visit different places
- 3. Preferably from the place/district of work
- 4. Good communication skills in local language
- 5. Any marketing experience/qualification will be given priority

Role of FLCRP:

- 1. To conduct FLCs minimum 2 every week
- 2. Enrollment of PMJDY, PMJJBY, PMSBY and APY (Monthly: 100, 100, 200 and 25), applications to be mobilized along with the required documents and to be submitted in concerned branch
- 3. To submit daily report by Whatsapp to FI Department
- 4. To submit a monthly report certified by BM, Nodal Branch to FI Department
- 5. To attend online and physical reviews from time to time
- 6. To mark attendance by video call every day
- 7. Any other work entrusted by FI Department
- 8. HO will provide all required publicity material in print and soft copies, a mobile projector will be provided.

Remuneration:

- 1. Minimum wages as skilled casual worker
- 2. Incentive if all monthly targets achieved on monthly basis
- 3. Fixed allowance of ₹ 300/400 per day if visit other places beyond 20 kms from Nodal branch
- 4. A two wheeler loan for purchasing a better vehicle may be sanctioned after successful completion of 6 months as FLCRP.

Places to be identified:

- 1. 2 or 3 places in every district except Aizawl (ex: West Phaileng and Mamit in Mamit district)
- 2. 5 in Aizawl city and 2 or 3 outside in the district

Training:

6 days induction training will be given initially by MiRB RSETI for certification and 1 day review and refreshing training during the first 3 months, thereafter 1 day review and refreshing training every quarter.

Type of Engagement:

Engagement of MRB FLCRP will be purely on contract basis for a period of 1 (one) year renewable subject to the performance of the FLCRP. The performance of the FLCRP will be reviewed and liable to be terminated if consolidated target is not achieved in a quarter during the engagement period.

This will be an additional support to Branches, Branches to continue with their efforts in FI activities.
