Applications received through proper channel and with verification of service particulars, SPE/D&AR/VIGILANCE clearance and enclosure of APARs will be preferred. On selection, the applicants will be allowed to join RLDA after NOC, vigilance/ D&AR clearance, and relieving by parent office.
