2. **Eligibility:**

- Candidates who have passed MBBS with PG Degree/Diploma/DNB in concerned specialty recognized by NMC and having registered with Delhi Medical Council or Applied for registration will be eligible. However Permanent DMC Registration Certificate for PG/DNB/Diploma is mandatory at the time of Joining.
- The candidate should complete the tenure of PG Degree/Diploma on or before the last date of submission of application.

3. **Pay Scale:**

Revised Pay Matrix Level-11 (Rs. 67700-208700/-) under CCS (Revised Pay) Rules, 2016 at entry level. Allowances as admissible will be paid.

4. **Age Limit:**

- Not exceeding 45 years (relax able by 5 years for SC/ST, 3 years for OBC) as on or before the last date of submission of application.
- Age Relaxation of 10 years for Persons with Disability (PWD) for UR, 15 years for SC/ST and 13 years for OBC candidates.

5. **Reservation:**

All reservations will be considered in the above posts strictly in accordance with prescribed norms/rules.

- SC/ST candidates to submit copy of community/caste certificate.
- OBC candidates should submit valid OBC Certificate as per OM No. 36036/2/2013-Estt.(Res-I) dated 31.03.2016 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi with non creamy layer certificate issued in present financial year.

- c. - d. Persons with disability (PWD) to produce/submit a certificate issued by a competent medical authority.

- i. The screening test of one hour based on the MCQs for the maximum marks of 60.
 - ii. Weightage of assessment will be of 40 marks.
 - iii. One (1) mark awarded for a correct answer and a negative marking of 1/4 (0.25) mark for each wrong answer.
 - iv. No negative marking for the non-attempted question.
 - v. The marks obtained by the candidates will be displayed on hospital website on or next day of examination.
 - vi. The list of qualified candidates (category wise) for interview/ will be displayed on Hospital website within three days of written examination.
 - vii. Candidates three times the number of vacancies (or less if not available) who qualify screening test will be called for interview.
 - viii. Final Merit list will be prepared on the basis on combined marks of screening test and assessment/interview.
 - ix. The candidates equal to number of vacancies available will be recommended for selection in each category.
