- (d) The application should be submitted affixing recent passport size photo attested by a Gazetted Officer and two photos in an envelope separately.
- (e) i) One set of copies of certificates attested by Gazetted Officer in support of items at serial Nos. 2,7,8,9,10,11 & 14 of the application should be furnished. If the application received is incomplete or if the Date of Birth certificate, Proof of qualification certificate and marks sheets, Study Certificate/ Residence Certificate as per the proforma, Caste Certificate (if any) are not enclosed, the application will be rejected and no correspondence on this will be entertained.
  - ii) Marks Sheets should invariably be submitted to evaluate the merit.
