CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period of **05 MONTHS** or till the project is over on a temporary contractual basis in the project entitled **“To provide technical support for development of sugar free cookies”(SSP-0347)** tenable at the Department of **Flour Milling, Baking & Confectionery Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Food Science and Nutrition / Food Science & Technology or equivalent.

Job Requirements: M.Sc. (Food Science and Nutrition or Food Science & Technology or equivalent) or 1-2 years of relevant work experience in reputed R&D organization .

Emoluments: Rs.15,000/- (Rupees Fifteen Thousand only) Consolidated per month .

1. Candidates should not have exceeded **50** years of age as on **25-03-2023** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSISTANT** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and on purely temporary basis for a period of 05 months or co-terminus with the project, whichever is earlier.

5. Performance of the Project Staff will be reviewed periodically. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.

7. If already the candidate is working in CSIR-CFTRI “No objection certificate” from the PI is mandatory at the time of interview.
