DETAILED VACANCY CIRCULAR

Applications are invited from the eligible officers for filling up the vacant post of **Professor (Sugar Technology)**, a General Central Service, Group 'A' Gazetted, Non-Ministerial post in Level-13 of the Pay Matrix at National Sugar Institute, Kanpur – a subordinate office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, by Deputation (including short-term contract). Details of the post, eligibility conditions etc. are given in the **Annexure-I**.

2. Applications of only such officers/ candidates will be considered as are routed through proper channel and are accompanied by:-

(i) Bio-data (as per the proforma given in **Annexure-II**) – each page of the Bio-Data and all supporting documents to be attested by an officer not below the rank of Under Secretary and certified by the Employer/ Cadre Controlling Authority.

(ii) Photocopies of APARs for the last five (5) years duly attested on each page by an officer not below the rank of Under Secretary.

3. Note 4: The period of deputation (including short-term contract), including the period of deputation (including short-term contract), in another *ex-cadre* post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years.

Note 5: The maximum age-limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

6. Place of Posting: The place of posting will be National Sugar Institute, Kanpur, Uttar Pradesh but liable to be posted anywhere in India.
