Candidates must submit self signed copies of relevant testimonial/certificate regarding educational qualification, age, caste, employment exchange registration card, valid driving license, experience certificate, if any and 2 (two) recent passport sized photographs along with the application. Mentioning of WhatsApp mobile no. on the application is mandatory.
- b. The list of eligible candidates for skill test/interview with allotted Roll Numbers and the date of skill test/interview will be published in the official website of Kamrup, Amingaon District Judiciary on **19/04/2023** i.e. **<https://kamrupamingaonjudiciary.assam.gov.in>**. No calling letters will be issued for the interview. The selected candidates as per the list will have to attend the skill test/interview.
- c. Candidates have to carry along all the relevant documents in **original** at the time of skill test/interview.
- d. No TA/DA shall be admissible for appearing in the skill test/interview.
- e. Candidates who are already in Government Service (Central / State or PSU) may apply through proper channel. They shall have to produce "No Objection Certificate" from the present employer at the time of document verification and they will have to submit release order at the time of joining.

3. **Other Terms and Conditions:**

- i. Candidates must not be less than 18 years and more than 40 years of age as on 01-01-2023. In appropriate cases, relaxation of age will be admissible as per the existing rules of government of Assam.
- ii. Eligible Candidates for skill test/interview have to produce their **Original** testimonials regarding educational qualifications, date of birth, caste, employment exchange registration card, valid driving license, working experience (if any) at the time of skill test/interview.
