Applications are invited from the eligible female candidates for the post of Accredited Social Health Activist (ASHA).

A. PERIOD OF RECEIVING ONLINE APPLICATIONS:

From 07.03.2023 to 18.03.2023 up to 12 O'clock midnight.

B. SELECTION CRITERIA:

As per Memo. No. HWF/NHRM-20/206/(Part-Il)1631 Dated 27.06.2012 of Govt. West Bengal, Health & Family Welfare Department (NHRM) and as per resolution made in the ASHA Selection Committee dated-28.02.2023.

- Selection is based on marks obtained by the candidates in the Madhyamik/ equivalent examination [without additional/optional/elective subject(s)] (90% weightage).
- Score in the interview (10% weightage).
- Preference would be given if possess experience certificate from competent authority in case of Grade-l & Grade-ll SHG members [from BDO]/trained dais or Link workers [from BMOH]. (If any).

C. **ELIGIBILITY CRITERIA**:

- 1. Candidate should be <u>married</u>, <u>divorced or widowed woman</u> (Certificate of marriage from competent authority is required).
- Candidate should be a resident of the <u>same service village</u> for which she will be selected. <u>Electoral Photo Identity Card/Voter's Card would be mandatory</u> for the proof of residential qualification. Considering the Service village it would be convenient to count the Polling Station Number/Part Number of the applicants residing ordinarily in the same Polling Station area.
- 3. Candidate should be <u>within the age group of 30-40 years</u>. In case of SC and ST candidates, the lower age limit is relaxed to 22 years (Caste certificate is mandatory for age relaxation). In both cases <u>age of the applicant means her age as on 01.03.2023</u>. In this case, the candidates must possess SC/ST certificate of Government of West Bengal to avail age relaxation. Caste certificate of other states would be treated as unreserved.
- 4. <u>Candidate should be at least Madhyamik passed or appeared or equivalent</u>. [from a board/council/institution/university, recognized/affiliated/registered by the Government of India or Government of state(s).]
- 5. Women candidates who are Madhyamik pass or possessing higher qualification are also eligible. However, in case of candidates possessing higher qualification, only <u>marks obtained [without additional subject(s)] in Madhyamik or equivalent examination will be considered</u>. Preference would be given if possess experience certificate from competent authority in case of Grade-1 & Grade-Il SHG members [from BDO]/trained dais or Link workers [from BMOH]. (If any).

D. MODE OF APPLICATION:

- Candidates should submit application through Online link "Application for the post of ASHA for Chanchal Sub-Division" in the website URL: www.malda.gov.in at recruitment tab.
- Candidate may collect information and assistance in filling up the Application Form from their respective Health Sub Centers / BPHC/RH.
- One candidate should submit one application. More than one application may cause cancellation of all the applications submitted by one candidate.

E. <u>DOCUMENTS TO BE REQUIRED AT THE TIME OF SCRUTINY/DOCUMENT VERIFICATION AND INTERVIEW:</u> [Candidate must carry self-attested Photocopy of following documents along with original]

- 1. EPIC/ Voter's Identity Card of the candidate.
- 2. Admit Card of Madhyamik or Equivalent Examination for proof of age.
- 3. Marksheet of Madhyamik or Equivalent Examination.
- 4. If the candidate possess any Caste Certificate of Government of West Bengal only for age relaxation (for SC/ST category).
- 5. If the candidate possess any experience certificate from competent authority in case of Grade-l & Grade-ll SHG member[from BDO]/trained dais or Link worker [from BMOH].
- 6. Two copies of Recent Passport Size Photographs.

F. GENERAL CONDITIONS:

- 1. Candidates, before applying, should carefully read the instructions and ensure fulfillment of the eligibility- criteria at the time of submission of application.
- 2. Submission of application does not guarantee an appointment.
- 3. Candidates shall be disqualified at any time and at any stage during the selection process, in case of any misrepresentation of facts and documents. Appropriate legal action may be taken against such candidate.
- 4. Chanchal Sub Divisional Level ASHA Selection Committee reserves the right to alter the modes of examinations or conduct, re-interview or cancellation of part or whole of any process of recruitment at any stage.
