State Bank of Sikkim operates as a commercial bank in line with any other banking institutions in the country and also functions as treasury bank to the Government of Sikkim.

Applications are invited from eligible Indian Citizens of Sikkimese origin having Sikkim Subject certificate/Certificate of Identification issued by competent authority of the Government of Sikkim for lateral appointment in the following posts on regular/contract basis in the State Bank of Sikkim.

## A. Competencies:

Preference shall be given to the candidates;

- Having good negotiation skills.

- Having good understanding of credit delivery system.
- Having hard working and proactive attitude.
- **B. Domicile:** Should be an Indian citizen of Sikkimese origin possessing Sikkim Subject Certificate/Certificate of Identification issued by the competent authority of the Government of Sikkim.
- **C.** Working officers should be able to report on duty within 100 days of appointment along with No objection certificate from the existing employer.
- **D.** Retired officers shall report within 30 days of appointment.
- **E. Other:** Candidates against whom there is/are adverse report regarding character & antecedents, moral turpitudes are not eligible to apply for the post.
- **F.** Officers retired on disciplinary grounds are not eligible

#### 2. SELECTION PROCEDURE:

Selection of the candidate shall be done on the basis of interview to be conducted by an Interview Board. Decision of the Interview Board shall be final and binding.

#### 3. PROCEDURE TO APPLY:

Eligible interested candidate, who aspires to join State Bank of Sikkim are required to submit application in the prescribed format as per Annexure-I along with copies of their testimonials in a sealed envelope, super scribing (APPLICATION FOR THE POSTS OF \_\_\_\_\_) between 23.03.2023 and 15.04.2023 (1500 hours) to the General Manager (HR), State Bank of Sikkim, Head Office, National Highway 10, Gangtok, Sikkim.

#### 4. FINAL SELECTION:

List of candidates finally selected will be made available on the Bank's website <u>www.statebankofsikkim.com</u> and in local newspaper.

#### 5. GENERAL INFORMATION:

- i) Candidates should satisfy themselves about their eligibility for the post applied for. The Bank shall determine their eligibility only at the time of interview and the decision of the bank shall be final and binding.
- ii) Candidates are advised in their own interest to apply much before the closing date and not to wait till the last date.
- iii) State Bank of Sikkim does not assume any responsibility for the candidates not being able to submit their applications within the last date on account of any reason whatsoever.
- iv) Candidates serving in Govt./Quasi Govt. offices, Public Sector undertakings including Nationalised Banks, Financial Institutions and Insurance Companies are advised to submit 'No Objection Certificate' from their employer at the time of interview, failing which their candidature may not be considered. In case of selection, candidates will be required to produce proper discharge certificate from the employer at the time of taking up the appointment.
- v) Retired Officers should submit their relieving letters from their employer(s).
- vi) Candidates falling under Scheduled Tribe/Caste/OBC categories should submit the category certificate issued by Competent Authority along with the application form.
- vii) Candidates are advised to keep their e-mail ID alive for receiving advices, viz. call letters/ Interview advices etc.
