Terms & Conditions:

1. Engagement will be initially for a period of one year, and may be extended or curtailed depending upon the project requirement, and desired level performance or conduct of the incumbent and availability of funds from funding agencies as the case may be.
2. The tenure of project staff shall be co-terminus with the project. However, under no circumstances the tenure would be allowed to exceed five-year duration. The performance of the Project Associate would be reviewed periodically so that any one not found up to the mark, could be terminated.
3. The position is only temporary and, therefore, will not confer any right on the incumbent to any claim, implicit or explicit on any post in CSIR-CIMAP.
