The Institute of Economic Growth (IEG), Delhi invites online applications for one post of **Associate Professor (Scheduled Caste)** on contract (against leave vacancy) at Pay Matrix Level-13A (1,31,100-2,17,100) in the **Agriculture Economic Research Unit** at the Institute. The application is to be submitted by May 10, 2023. The position carries usual allowances admissible from time to time at the Institute.

The Institute is an autonomous research and training organization established in 1952. The Institute's faculties work in several areas of Economics, Demography, Development and Sociology.

Minimum Qualification

Eligibility:

- (i) A good academic record, with a Ph.D. Degree in Economics/Applied Economics.
- (ii) A Master's Degree in the subject of Economics/Agricultural Economics, Development Economics/Statistics with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- (iii) A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix-II, Table 2.

Age: The candidates should preferably be below 40 years (relaxable in deserving cases).

General Instructions for Candidates

1. The application has to be filled out online on the Institute's website i.e. www.iegindia.org under the "Career" web link along with the instant advertisement. Application is to be submitted by **May 10, 2023**.
2. After submission of online application, applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Also require to send the names of three references and copies of the five best publications and API score form duly filled in by post.

On the top of the envelope, write "Application for the Post of Associate Professor, Agriculture Economic Research Unit, addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi-110007. The hard copy of the application with other documents should reach the Institute latest by **May 22, 2023**.

3. Those who have applied in response to the advertisement dated December 27, 2022 for regular position and are interested for the contractual position need to inform the Institute through email/letter about the interest to consider his/her application.

4. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel.
5. Applications which do not meet the criteria given in this advertisement and/or incomplete applications are liable to be summarily rejected.
6. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely on the basis of information/documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.
7. Candidate called for physical interview should report along with all the testimonials/certificates in original along with photo ID as per eligibility conditions.
8. Candidates should possess the prescribed qualification and experience as of the closing date of application.
9. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria may be applied for short-listing the candidates to be called for an interview.
10. No correspondence or personal inquiries shall be entertained by the Institute. Correspondence, if any, in this matter will be sent to the e-mail ID of the candidate.
